1. Accounting Policies

The Society follows generally accepted accounting principles and their application is consistent with previous years.

## Expenditures

Expenses are recorded in the accounts on an accrual basis, and provisions are established for uncompleted purchase orders and services.

## Depreciation

Equipment is stated at cost less accumulated depreciation which is calculated on a declining balance basis at the rate of $20 \%$ per annum.

## Capitalization

All major acquisitions of fixed assets or additions which extend the useful lives of existing fixed assets are capitalized in the accounts.
2. Loan Payable

This loan was obtained from McGill University interest free on the conditions the balance be repaid in equal instalments on May 31,1979 and on May 31 , 1980. However, if these repayment terms are not met, the loan is extended to May 31, 1981 and interest is payable at the prime interest rate.
3. Light, Heating and Air Conditioning Expense

Light, heating and air conditioning expense of $\$ 152,981$ for the University Center have been paid by McGill University on behalf of the Society (1978$\$ 125,000)$.
