Student Democracy and Constituencies

Judicial Board – We should have the final law student Justice in about a week's time. I will be interviewing the "member at large" J-Board Justice in the next week and a half. These will then be brought to Nominating Committee, and we will have a full J-Board in about two weeks' time.

Council – Still proceeding well! We will start having "roaming" Council meetings for the next meeting or the meeting after. We will proceed to have a roaming Council every other meeting. The location will be determined in the next few weeks. If you have any suggestions for locations, please send them my way! Additionally, we will be trialing a standard live stream of all Council meetings. We will do this for the next four meetings and measure popularity; continuation of this practice will be based in the evaluations.

We will have an excellent workshop at the start of the GA to go over the basics of Robert's Rules and talk about how a GA works. There will be several "info staff" walking around to help students who get lost in the procedures or who have questions about whatever is going on. I have booked alternative spaces as overflow space just in case we have large turnout. Motions will be published on October 2.
