 - The first clause of the motion (the only clause) has been amended to make it more relevant to the SSMU and an internal rather than external matter to the Society

 - This motion was not added to the agenda by Steering Committee because concern was raised over its constitutionality
 - The resolved clause renders every final substantive vote a roll call vote; Steering Committee felt that this would be unnecessary to mandate because there already exists a "motion for a roll call vote"
 - Mandating every vote to be a roll call vote would undermine Robert's Rules of Order as it would essentially take away the right to not have a roll call vote (the status quo practiced with Robert's Rules)
 - Rather than mandating every final vote to be a roll call vote on the record, Councillors can motion for a roll call vote after the previous question has been moved and prior to voting itself
