Club Applications: We have steadily been receiving more and more of these and will have to start evaluating them at the Interest Group Committee!

Club Forms: The process is slower than I would like so I will be meeting with the various people who deal with any of the club-related forms in order to help streamline the process a bit more.

Referenda: Midnight Kitchen is running an existence and fee increase referendum. I have been meeting with them to discuss the timeline of the elections and how the campaigning process works including the various do's and don'ts.
