 - In 2013, FECQ, TaCEQ and FEUQ signed on as interveners in the Laurent Proulx case. Laurent Proulx and Miguael Bergeron, both ULaval students, submitted an application to the Superior Court of Quebec in 2013 contesting the constitutionality of seven articles in Quebec's Act Respecting The Accreditation And Financing Of Students' Associations (ARAFSA). Obviously, this would have serious consequences if it were to pass. The case was quiet until this summer, and is now being brought to court in December. TaCEQ's former lawyers contacted me to gain permission to continue representing the SSMU in this case (at no financial cost to the SSMU) and I've signed in affidavit in this regard, and may be asked to participate in the proceedings.
 - TL;DR student associations are in court battle with ULaval student Laurent-Proulx for our existence
 - Had a meeting about this on Friday November 14th. Will be going to the trial as a representative on December 9th.
