# **Mental Health**

### Mental Health Portfolio Updates:

- The first annual cross-campus Mental Health Awareness Week was completed!
  - over 20 events were hosted with partners across campus
  - special thanks to all of our students facilitators, RezLife, Student Services, and Healthy McGill!
- Met with Counselling Services on Nov.17th to discuss student priorities for Counselling Wellness Website + Counselling Services itself
  - will be having follow-up meetings regarding creating accessible channels for student feedback

#### Mental Health Committee

- Committee will be launching a Facebook Page and listserv soon
  - seeking to make listserv opt-out (strong majority supported opt-out v. opt-in on Facebook poll; will reach more students); currently looking into legal constraints re: recent anti-spam laws
- Committee is also working to develop 'how to' guides for accessing support and accommodation for mental health challenges at McGill

Equity Committee

- Working group to review the Equity Policy has been formed and has met twice
  - plan for consultation re: punitive measures and accessibility will be forthcoming

## Libraries Portfolio Update:

- received ample feedback from councillors in response to blurb re: 24 hour access and priorities circulated prior to last council—thank you!

#### Library Improvement Fund Committee

- decision was made to fund Winter 2015 24-hour library access; lobbying will continue for 24-hour access to be considered an operating expense
- compilation of feedback from whiteboard/tabling efforts in early November nearly complete
  - some early findings re: priorities include: opening the Redpath doors, more comfy chairs, and better heating
- online survey re: Library priorities will be circulated this week for LIF priorities + Library Master Plan priorities (i.e. more group space, more quiet space...)

#### Library Master Plan

- Library Master Plan Feasibility Study Town Hall (Nov.11th) was well-attended
  - biggest student concerns came from Music students re: possible plan to convert Redpath Hall into a reading room (currently a performance space)
- next Communications Working Group meeting will be December 9th
- LIFC consultations will also be used to inform the student priorities at Communications Working Group and Steering Committee
