

## Motion Regarding the SSMU's Opposition to Deregulation and Increase in Tuition

Whereas, tuition deregulation means that McGill University would be allowed to charge students any amount for out-of-province and international tuition;

Whereas, in 2008 McGill University successfully lobbied the Québec government for a deregulation of tuition fees for six programs (Applied Science, Mathematics, Engineering, Computer Sciences, Management, and Law)<sup>1</sup>;

Whereas, this deregulation resulted in an increase from roughly \$2000 to \$30000 per year for students enrolled in McGill's MBA program<sup>2</sup>;

Whereas, the <u>McGill administration is currently lobbying the Québec Government to</u> <u>deregulate tuition for all programs</u>, at both the undergraduate and graduate levels, in the same manner as for the first six <sup>1</sup>;

Whereas, the McGill administration has stated that it has no plans to consult international students in shaping its stance;

Whereas, the <u>Politique québécoise de financement des universités</u> was recently released and similarly calls for deregulation of out-of-province and international tuition in all programs and at all levels [see page 163] <sup>3</sup>;

Whereas, the Quebec government is also moving to increase French student tuition by around 180% <sup>3</sup>;

Whereas, this demonstrates systematic efforts being made to increase student tuition in order to compensate for provincial cuts to post-secondary education and the public sector;

Whereas, more than 50% of the Student Society of McGill University's (SSMU) membership consist of international and out-of-province students <sup>5</sup>;

Be it resolved, that the SSMU take a stance in opposition to the deregulation and increase of international tuition fees to be communicated through mobilization via the Vice-President (External Affairs);

Be it resolved, that the SSMU condemn the McGill administration for their lack of transparency and consultation on this issue through a post on the website and an open letter to be composed by the Vice-President (External Affairs);

Be it resolved, that the SSMU councillors be conduits of information regarding the impacts of tuition deregulation between SSMU Council and their constituents, and report their activities in their biweekly councillor reports.
