### **Personal**

#### **Office Hours**

#### **SSMU Elections**

---

I met with two candidates since last Council to discuss my portfolio and answer any questions that people might have about running for my position.

#### **Club Representative**

Victor Gassmann was successfully elected to the vacant Club Representative seat! 34 clubs voted (quorum was 24 clubs or 10%), 27 for, 3 no and 4 abstain. The results will be sent out by listserv tomorrow.

The final round of workshops was held since last Council. A total of 17 clubs were found to be completely inactive and have lost their status. Of the 234 clubs that are currently active, a total of 230 or 98.72% have attended the event.
