Portfolio Updates:

- Senator Greenspon and I are this week to finish the Fall Reading Week survey for circulation in mid-March
 - meeting with Enrolment Services to work through new modelling options (November & October breaks)
- short SSMU policies to write before end of year: family care policy, consent campaign support policy (mandated by Council; will write for 26th), & military research policy
- SAP Updates:
 - revised SAP heavily to rights-based framework for last week's scheduled Deans' Working Group (cancelled, moved to "very soon")
 - met with MUNASA this Wednesday re: SAP; will be meeting again next Wednesday
 - presented to EUS for endorsement on Monday and AUS on Wednesday
 - endorsements received from both!
 - happy to present at other councils in future weeks
- working heavily on Traditional Territory Acknowledgment Policy
 - presented at Joint Board-Senate Committee on Equity pre-Reading Week
 - working up Executive Summary document for presentation to community members
 - was seeking for For Information presentation at March Senate and For Approval at April Senate, but looks like it may be April For Information and For Approval in May
 - will be meeting with McGill Legal Services over next few weeks
