## ARTICLE 1: Name

1.1 The name of the Association shall be "McGill University Hellenic Students" Association." The Association shall be an apolitical body with aims as outlined in Article II. By apolitical it is meant having an aversion for or no interest in any politically polarized opinion and/or event. ## ARTICLE III: Membership

a) Member. (Throughout this constitution, Member with the capital letter $M$ shall denote a member of the Association as defined in this article.)

A Member shall be any student regardless of descent who is a member of PGSS and SSMU. He/she is entitled to be a Member provided he/she has paid the annual membership fee and whose actions do not contradict the aims of the Association. A Member has the right to vote during a General Assembly as well as the right to be nominated as a candidate and/or be elected for the Executive Council. In addition, a Member has the right to attend Executive Council Meetings as defined in Article 4.2.
b) Honorary Member.

An Honorary Member shall be any person, regardless of descent, who is deemed to have contributed positively to the existence of the Association. The Honorary Member and his/her nomination and consequent membership must be approved by the General Assembly with a majority vote. The Honorary Member does
not pay the annual membership fee, nor does he/she have the right to vote, or to be nominated for a position on the Executive Council.
3.2 a) The rights of a Member, not including voting rights, as defined in Article 3.1. are bestowed immediatelv upon him/her upon receint bv the Association of the annual membership fee. For voting rights, refer to Article 6.3.
b) The membershin fee shall be five dollars $(5.00 \$)$ annuallv.
3.3 Should anv Member. or Honorary Member act in anv wav that violates this Constitution. he/she shall present himself/herself before the Executive Council which will take appropriate action depending on the severitv of the violation. By "approbriate action" it shall be meant anv reprimand raneing from a warning to a complete suspension of the Member's or Honorarv Member's rights immediatelv.
3.4 Should the reprimanded member wish to appeal, he/she may do so at the next General Assembly. Those present shall listen to the case and the appeal and vote by a show of hands whether to reinstate the rights to the member or not. The result of the vote shall be binding.

## ARTICLE IV: Governing Bodies of the Association

There shall be two (2) governing bodies of the Association:

> (i) The General Assembly
> (ii) The Executive Council

### 4.1 The General Assembly

All Members constitute the General Assembly. The General Assembly shall be the highest bodv of the Association. having the right to make binding decisions on anv issue relevant to the Association and to supervise the Activities of the Executive Council. d) The Vice President (External Affairs) shall be responsible for all matters concerning the relationship between the Association and all individuals and organizations external to the Students' Society of McGill University and the University itself as a
whole. The individuals and organizations with which the Association will engage, will be determined by the Executive Council.
e) The Treasurer shall be responsible for the planning and administration of the finances of the Association. The Treasurer shall present a budget to both the SSMU and the General Assembly in the Fall Semester. In addition, he/she shall keep a detailed record of all revenues and expenditures which shall be presented to the General Assembly at the end of the term of office of the Executive Council. In addition, Public Relations shall be responsible for the advertisements of any events oraganized by the Association; this includes radio and TV. Also, Public Relations shall be responsible for the collection of sponsors for the annual yearbook with the help of other officers of the Executive Council.

ARTICLE V: General Assembly
5.1 The Executive Council shall call a General Assembly as outlined in Article 4.1. Notice of such meetings shall be published in the McGill Daily and/or the McGill Tribune at least one week in advance.
5.2 All motions passed at a General Assembly shall become official Association policy and shall take precedence over motions passed by the Executive Council or during past General Assemblies. Ouorum required for a General Assembly shall be

8.6 Should quorum fail to be achieved, the Special General Assembly shall reconvene within one (1) week and fifty percent ( $50 \%$ ) of all members shall constitute quorum. The dissolution shall occur only as outlined in Article 8.5.
8.7 The General Assembly shall nominate three (3) members of the Association to be responsible for settling any debts with the Students' Society of McGill University and any other individual or organization on or off the island of Montreal. Any remaining assets shall be donated to various Greek charitable organizations as directed by the Special General Assembly.
8.8 The dissolution of the Association shall not become effective until ratified by the Students' Society of McGill University.

## ARTICLE VI: Elections

6.1 Elections shall take place in March during the Winter Semester, the date, time and place to be determined by the Executive Council. The Election date shall coincide with the date for the last Winter Semester General Assembly. See Article 4.1.
6.2 The Executive Council shall make public the date, time and place of the General Assembly/Elections at least two weeks in advance.
6.3 Any member who has paid his/her membership fee may nominate another, who has paid his/her membership fee, for a position on the Executive Council. Nominations are acceptable in written form before the election date (submitted to the Executive Council) and on the date of Elections verbally. All voting members must have paid the membership fee one month in advance of the Election date.
6.4 On the election date, voting shall be by secret ballot. Votes by proxy shall be unacceptable.
6.5 a) Should the number of candidates be equal to the number of Executive positions, then, the candidates shall be considered elected by acclamation.
b) Should the number of candidates be less than the number of Executive positions, then, the candidates shall be considered elected by acclamation, with the provision that through a by-election, they will fill the vacant positions. It shall be the responsibility of the new Executive Council to determine and announce to the members the date, time, place and procedure for the by-election.
6.6 Should for any reason, a position be vacated by an executive officer before the end of term, the Executive Council shall select a temporary replacement from among the members of the Executive Council, the replacement's term ending on the date of the next General Assembly where a permanent replacement shall be voted on by the General Assembly; see Article 6.3.

## ARTICLE VII: Amendments

7.1 Should amendments to this constitution be deemed necessary, a General Assembly shall be called, in order for members to vote on amendments suggested by the Executive Council.
7.2 Two-thirds (2/3) of the members of the Association shall constitute quorum for the purpose of making amendments to the constitution. Failing to achieve this, the General Assembly shall reconvene within one (1) week and those members present shall constitute quorum.
7.3 An affirmative vote by two-thirds (2/3) of members present shall be required for any amendments to this Constitution.
7.4 Any amendments shall not become effective until ratified by the Students' Society of McGill University.

## ARTICLE VIII: Dissolution of the Association

8.1 By "dissolution" it shall be meant the cessation of existence in any form of the McGill University Hellenic Students' Association.
8.2 No Executive Council shall ever have the right to propose dissolution of the Association. Only the General Assembly shall have the right to make such a proposal.
8.3 Should such a proposal ever be brought up and accepted by the General Assembly, the Executive Council shall convene a Special General Assembly with the sole topic: "The Dissolution of the Association."
8.4 Quorum at this Special General Assembly shall be constituted by a minimum of ninety percent ( $90 \%$ ) of all members.
8.5 The dissolution shall occur only if ninety percent ( $90 \%$ ) of those present vote affirmatively for such to occur.
8.6 Should quorum fail to be achieved, the Special General Assembly shall reconvene within one (1) week and fifty percent ( $50 \%$ ) of all members shall constitute quorum. The dissolution shall occur only as outlined in Article 8.5.
8.7 The General Assembly shall nominate three (3) members of the Association to be responsible for settling any debts with the Students' Society of McGill University and any other individual or organization on or off the island of Montreal. Any remaining assets shall be donated to various Greek charitable organizations as directed by the Special General Assembly.

88 The dissolution of the Association shall not become effective until ratified by the Students' Society of McGill University.
