## ARTICLE I - NAME

• The name of the organization is the Lebanese Students' Society of McGill University (LSS).

# **ARTICLE II - DESCRIPTION**

• LSS is a non-profit, non-religious, non-discriminatory, apolitical student's society.

## **ARTICLE III - OBJECTIVES**

### **PRIMARY OBJECTIVE**

• To offer our members the true taste of Lebanese culture and free spirit, through various fun and interesting activities.

#### SECONDARY OBJECTIVES

- Represent Lebanon in multicultural events at McGill University.
- Establish correspondence between students at McGill and others in many universities around the world.

# **ARTICLE IV - MEMBERSHIP**

- Any McGill student is eligible to become a member of LSS.
- Any non McGill student is eligible to become a member of LSS.

# **ARTICLE V - THE BOARD OF DIRECTORS**

## DESCRIPTION

- The Board of Directors will be referred as the BOD in this Constitution.
- To be elected to the BOD, an LSS member has to be a registered student at McGill University.
- The BOD for the next year will be elected in March of the current academic year. This BOD will be the "Associate BOD" of the current BOD until May 31<sup>st</sup> of the current academic year.
- On June 1<sup>st</sup> of the new academic year (June 1<sup>st</sup> May 31<sup>st</sup>), the "Associate BOD" becomes the "Official BOD" of LSS.
- Two members of the BOD will be selected as administrators. They will conduct internal meetings and represent LSS in SSMU. They are the only two members eligible to sign checks.

# DUTIES

- With the election of the "Associate BOD" in March of the current year, a tentative schedule for the upcoming year must be drawn up and budgeted for.
- Each member of the "Associate BOD" must be assigned an activity for the upcoming year.
- A minimum of one member of the BOD will direct that activity.
- The director(s) of the activity will allocate duties to the other members of the BOD.
- A member of the BOD may be reassigned to another activity if a majority of the BOD believes that he/she is not capable of fulfilling his/her obligations to that activity.
- The BOD decide unanimously on the activities that will be organized during the year.

#### IMPEACHMENT

- If a majority (2/3) of the BOD believes that any member(s) of the Board is not fulfilling his/her obligations in respect to the Society, then that person(s) must resign from the BOD immediately, having the option of becoming a regular LSS member.
- If a majority of members (51%+) agrees that the Official BOD is not fulfilling its duties, then the BOD must resign immediately, having the option of becoming regular LSS members.
- LSS members would then conduct an "Emergency General Election" to elect a new BOD who they deem worthy.

#### **ARTICLE VI - ELECTIONS**

- All members are eligible to vote for the "Associate BOD".
- The LSS "General Election" shall take place annually during the month of March to elect the "Associate BOD".
- Ten people will be elected to the "Associate BOD."
- Members will be personally informed prior to the Assembly of which LSS members are running for the BOD.
- If anyone can not attend this Assembly and willingly submit his/her vote, then that vote will be legitimate.
- All votes at the General Assembly are legitimate.

•The "Associate BOD" will be elected by a majority of votes.

#### **ARTICLE VII - MEMBERSHIP DUES**

- Any member recruited at the beginning of the current academic year pays an annual membership fee of five dollars (\$5.00).
- Any member who, before June 1<sup>st</sup> of the next year, wishes to renew his/her membership for the upcoming year, pays an annual fee of four dollars (\$4.00).
  (Values are subject to change.)

### **ARTICLE VIII - AMENDMENTS**

- The BOD can recruit new members to the Board who it feels are eligible to fulfill LSS obligations.
- This constitution can be revised at any time by the BOD with the consent of a majority (2/3) of the BOD members, a 51%+ majority of LSS members, and the approval of SSMU.
