# **Full Status Applications:**

## McGill Students Yoga Club

### Afghan Students' Association

### Committee Recommendation: Table

The Committee recommends that the Interim Status Application of the Afghan Students' Association be tabled until the club provides further details about strategies for financial sustainability, as this was not addressed in their original application.

### **Constitutional Amendments:**

The Korean Students' Society (KSS)



After review of their constitution on October 17, the committee recommended that their amendments be approved with the provision that they edit Article XI – Electoral Procedures to entail that the executive selection committee is chosen by the general members and not just the executive team. In response, they have suggested an electoral process that consists of an interview by executive members chosen internally and an election by general members. Each of these components would constitute 65% and 35%, respectively, of an individual's final score.

Overall, the Committee felt that this system still gives too much of the decision to current executives, while only giving a minor democratic power to members. Our next suggestion to them will be that the interview be a way for executives and individuals to gauge qualifications and fit for positions but not hold weight in the overall decision. In other words, the election should constitute 100% of the decision. An alternative suggestion would be to follow what we have recommended for McGill Students for Think Pink below.

### Committee Recommendation: Table

The Committee recommends that the decision to approve the Korean Students' Society's constitutional amendments be tabled until a consensus regarding electoral procedures can be agreed upon.

#### McGill Students for Think Pink

The Electoral Procedures also consist of solely internal appointment, which the Committee advises against. Our recommended revisions would be to elect the co-presidents by general members and maintain appointment of other executives by the co-presidents.

#### Committee Recommendation: Table

The Committee recommends that the decision to approve the McGill Students for Think Pink's constitutional amendments be tabled until a consensus regarding electoral procedures can be agreed upon. All other amendments were approved.
