Transition Process

This is perfectly normal and allowed however specifics of when we will have everyone registered are still important.

of the auditor). Though the GA didn't meet Quorum we're hoping this can act of as a fire under the administrations feet to have them act sooner. In recent conversations with Chris Buddle (the Dean of Students) we were told that they would be discussing the topic this week and in advance I've started to collect some documents showing how this lack of recognition by high level administers as to the importance of student decision making negatively affects turnout and representation at the GA. PRESIDENTS' ROUNDTABLE

We've decided to change Presidents Round Table to once every two weeks. Things we worked and are continuing to work on collectively include the post-election support letter, Mental Health 101 and individualized faculty-level Mental Health faculty training initiatives, the Menstrual Hygiene Products Fee, and Centraide.

POLICY PROJECTS

Ethical Expenditures Policy

We have a rough draft of the Policy done and are looking for feedback now. If anyone reading this is interested (Councillors, Members, or other) please feel to reach out. There has been one conversation about including companies that support political individuals or institutions that themselves promote harmful ideologies, but looking for input on that.

Menstrual Hygiene Products Policy

SQ Done, pending approval by Council.

Conflict of Interest Policy

We've decided this would be better as a procedural practice & has sparked a larger conversation as to how our Policy and Plan book currently works. We're potentially looking at remodeling that book to look



more like a Policies, Plans and Procedures book to better emphasis the need for more pragmatic internal procedures *in addition to* a lot of our conceptual and ideological mandates. This will hopefully better outline how we function to those working with us internally & to the Membership.

Equitable Hiring Practices Policy/Amendments to the HR Policy

Out for internal consultation (predominantly with Equity Commissioners). Once we're passed that stage we'll build it up more and send out for external consultation.

Amendments to the Accessibility Policy

REPRESENTATION & ADVOCACY

SQ – the Working Group for the Accessible Events Checklist just booked their next meeting so I am currently just waiting for us to meet. We are still in the process of figuring out how it can be implemented and formatting it to be more accessible itself.

Senate Committee on Physical Development (CPD)

SQ – The Committee hasn't yet met for the year, though it did meet a few times over the summer to wrap up some unfinished business and do some brief introduction to some of the new members of the Committee.

Enrollment and Student Affairs Advisory Committee (ESAAC), Subcommittee on Student **Affairs Policy (SSAP)**

SSAP met a few weeks ago and we talked about Mental Health 101 mandatory additions to the requirements for the Tenure process and there was support for the idea. It's now being kicked up to ESAAC.



BOARD OF GOVERNORS (BOG)

Board Reform

Leslie Anne has submitted a 'final rough draft' of the report, which is currently being reviewed for extra edits but we're on track to how it out next week.

I'll be going to the Nominating, Governance and Ethics Committee (NGE) meeting on November 29th from 3-5 to talk about the report that the BoG will be producing through the Committee. I sent a Motion/letter to them for approval but it has been redirected straight to the Committee.

Pre-Board Meetings ('BoG Caucus')

BoG Caucus met last week to go over some of the documents that were given to us in prep for the Joint Board-Senate meeting on Sustainability. I gave out an early draft of the report Leslie-Anne has been putting together as well for feedback. After we get more comments back we'll be trying to edit to report to match.

Presentations and Executive Shadowing

Erin and I made the presentation for Board and sent it in for review so we're just waiting to hear back from them. The first Board meeting is taking place next week.

SQ – Exeuctive shadowing for students has been pushed back to second semester sadly due to some of the unexpected events of first semester but Etienne and I have made a form and are ready to go with the program whenever.

CAMPUS RELATIONS

Deputy Provost, Student Life & Learning

Centraide

SQ - The Centraide campaign is something the President of SSMU usually has some involvement in, and this year Ollivier (the DPSLL) will be one of the Co-Chairs of the Committee that will be helping coordinate the campus wide-initiatives related to it. We had a meeting this week to go over some of the things we could do (raffles, competitions, etc.), and I brought it up at PRT to see if faculties would be interested in getting involved again.

MOA

Jonathan is taking a while to get back to us on this but we've had conversation in both MOA meetings and others that have suggested we'll be removing the McGill name regulations, removing some of the



restrictions on advertising on campus, and adding in some info that the Office of the DPSLL will be providing us on future years to make our lives easier (e.g. global class lists).

Post-Election Support

In a meeting with the DPSLL (Ollivier Dyens) and the Provost (Christopher Manfredi) we asked the administration to sign on to a bi-partisan letter that addressed internal ramifications of the US election (e.g. assuring students, particularly marginalized students, on campus that resources exist and we are committed to both continue supplying and improving them). This was unfortunately met with strong resistance, with the administration's response mainly highlighting there long-held belief that McGill is not affected by external events and that no letter insuring international & marginalized communities (faculty, student & staff) that McGill is committed to supporting them would be signed onto by them.

Things that my Action Team have been talking about include: the addition of a McGill Positions Book to building accountability, usability and transparency in relation to any actions taken by McGill's Vice-Principal (Communications & External), the creation of a Taskforce of Climate Change Prevention/Carbon Neutral Campus action, Divestment from Fossil Fuels, and Equitable Governance Reform.

room for a larger conversation. This however has not yet (and may never) been brought to him or his Office.
