1. FINANCE

Budget

- Posted \$31,000 deficit over Q1 + September versus \$44,000 the previous year. Will be working with VP Ops this week to bring a presentation to ExCom next week regarding our opinion on their operational sustainability. Promising
- Samosa catering for student groups: Idea that was born out of Fundcom last week, could be an additional revenue stream for kitchen catering.
