
REPORT OF THE PRESIDENT

WHAT DOES THE PRESIDENT DO?

PRESIDENT. The President shall exercise the following powers and perform the following duties: to be the chief officer and chief spokesperson of the Society; to ensure the long-term integrity of the Society; to enforce the Constitution and Internal Regulations of the Society and ensure the maintenance of the governance documents; to chair and coordinate the activities of the Executive Committee; to manage the Society's human resources; to call meetings of and set the agenda for the Legislative Council and the Board of Directors; to manage relations between the Society and the administration of McGill University; and to represent the Members on the University Senate and Board of Governors.

Board of Governors

Board of Governors' meetings

- Began attending Board of Governors' meetings ahead of the start of my official mandate on the Board of Governors (June 1st, 2017 when my mandate as President starts) since there was a vacancy on the Board of Governors due to last year's resignations.
- > I attended the May 25th Board of Governors meeting, which was the last Board of Governors meeting of the 2016-2017 academic year.
 - Some highlights from the meeting:
 - Principal and Vice-Chancellor Fortier was approved for a second fiveyear term;
 - The provincial government launched an Artificial Intelligence (AI) Supercluster and would be providing \$100 million for the initiative;

- Presentation by Victor Frankel, Post-Graduate Students' Society's (PGSS) Secretary General on the activities and mandate of PGSS.
- ➤ Lattended a Board of Governors Governance Session on September 6th, 2017.
 - o At the meeting, information on best practices for Governors was provided.
- ➤ I attended the Board of Governors Orientation on September 18th, 2017.
 - o At the meeting, an overview on (a) McGill's history, values, and structure, (b) Board of Governors structure, (c) obligations and responsibilities as Governors, and (d) current initiatives at the University was presented.
- ➤ I attended the October 5th, 2017 Board of Governors meeting, which was the first Board of Governors meeting of the 2017-2018 academic year.
 - Some highlights from the meeting:
 - Provost Manfredi delivered the Report of the Task Force on Indigenous Education;
 - Provost Manfredi delivered the Progress Report on Open Forum Sustainability Recommendations;
 - The Vice-Principal (Administration and Finance) Yves Beauchamp delivered the Annual report on Sustainability;
 - The Dean of the Faculty of Agricultural and Environmental Sciences, Professor Anja Geitmann, delivered a presentation giving an overview of the Faculty of Agricultural and Environmental Sciences (at the MacDonald Campus);

- During the month of May, as part of our training, the Vice-President University Affairs and I attended the last Senate meeting of the 2016-2017 academic year as well as MAUT's Pre-Senate Lunch.
 - o MAUT Pre-Senate Lunches are a space for various university staff, professors, and student representatives to discuss the Senate documents ahead of the Senate meeting.
- ➤ Lattended Senate Orientation held on September 13th, 2017.
 - o Senators were taught all basic skills required to successfully participate in Senate meetings.

- ➤ I have attended the first Senate meeting of the 2017-2018 academic year held on September 19th, 2017.
- > I will be attending the next Senate meeting this upcoming Wednesday (October 25th, 2017).
- > At Senate Caucus before the next Board of Governors meeting, I will be presenting a short report prior to the BoG meeting to consult Senators.
- After each BoG meeting, I plan on distributing my notes from the Board of Governors meeting to enable SSMU Representatives to discuss any points of interest at the Faculty Council level.

Human Resources and Legal

- > Student Staff Orientation
 - o With the help of HR Manager, Kibi Zhu, I prepared a student-staff orientation that took place on September 14th and September 15th.
 - Student staff attended workshops on equity, sustainability, IT, and various office trainings.
- Student Staff Training
 - o In order to ensure that throughout this year, institutional memory is guaranteed for next year, I am working with my student staff to produce a check-list of everything that is expected of them in their portfolio.
 - This way, it guarantees that no deadlines are missed and all of our mandates are followed.
 - First document already produced by the DEO.
 - o I have supervised the training of 3 Recording Secretaries, DEO, Secretary-General, Speaker, and Parliamentarian.
 - Worked closely with the CEO to establish electoral timelines since it was not done last year.
- SSMU DayCare and SSMU DayCare Board of Directors
 - o Dealt with some issues in May, hired a team to aid the management of DayCare affairs.
 - Worked closely with the General Manager to address any DayCare issues that arose during the summer.
- Supervised of Courtyard Coordinators (2)
 - It is the first year of this project.
 - The project is coming back in the Spring of 2018.
 - Successfully went through SPF.
- > Dealt with various HR matters that came up since May.

Board of Directors

The decisions and the minutes for 2015, 2016, 2017 have been approved and processed this July.

Management of relations between the Society and the administration of the University

- Accomplishment: re-establishing a relationship of mutual trust and respect between the SSMU and members of the McGill Administration.

- > Set the dates for this year's LC.
 - o Currently working on finding a space for the Winter Legislative Council and GA.
 - Also working on setting the dates for next year's Legislative Council and GAs in order to ensure that we have a space to host them while the building is being renovated.

Networking and Relationship building

- > Attended the Student Care Conference (*NEW) (May 24th and 25th).
 - o It is the first time in many years that SSMU execs have attended this conference.
- > Attended the SUDS 2017 Conference (Student Union Development Summit).

 - Answered questions of first year students and their parents.
