Charity Week

The holiday break was extremely productive for myself, and most of my coordinators. After meeting briefly before final exams started, I ascribed roles for each of them, (administrative, sponsorship, marketing/promotions) and we selected the Tyndale St-Georges Community Centre as our charity, which provides empowering programs and services to the community of Little Burgundy. We have finalized the majority of our events for the week, which will include a coffeehouse/open mic night, a Krispy Kreme sale and three simultaneous samosa sales across the campus, a silent auction, a film screening, a charity concert, StarCraft competition, yoga/Zumba/tango/pilates instruction, a fashion show, and a charity ball. This year, we are aiming to raise around \$5,000 for the Centre, and hope to establish the AUS as a faculty association with a strong commitment to philanthropy. Charity Week 2012 will be taking place from Monday March 5th to Saturday March 10th, 2012. Additionally, the Arts Fashion Show is looking for models, and will be hosting auditions on Wednesday March 25th and Friday March 27th in the Arts Lounge, from 6PM-8PM, so if you/your friends/executive are interested, please contact me after Council!

CoffeehAUS

The first CoffeehAUS took place on Tuesday evening, and was a huge success! My coordinators and I restructured the event, with a heavy emphasis on marketing and promotions across campus and different social media platforms, as well as adding both a charitable and sustainable element to it. We are charging patrons \$1 entrance with a reusable cup, and \$2 without. All of these proceeds will go towards Project Futures Canada, a not-for-profit organization that seeks to educate and eliminate human sex trafficking globally. Future events will feature spoken word artists and slam poets that have performed at The Yellow Door and Le Divan Orange, as well as McGill-based musicians. The

External Affairs/Community Engagement Committee

One of my long-term goals for the AUS is for the Society to become more engaged with both the Milton-Parc and McGill community. As such, this semester I will be working to implement an External Affairs/Community Engagement Committee, which would seek stronger relations with the Milton-Parc Citizen's Committee, in the form of monthly debriefs, and events that would be mutually beneficial, as well as events/partnerships with groups across the McGill campus (SEDE, Chaplaincy Services, and The Office of Sustainability). Additionally, the group would seek financially ethnical contracts with external companies that would directly benefit students. I'm still in the early planning stages for how this committee will be structured, but am aiming to have a Constitution drafted by early February, and begin recruitment shortly thereafter.

Over the break, the other co-editor-in-chief and I selected new writers and freelancers for the magazine. We have some exciting events planned for the semester, aside from the publishing side of things. On Tuesday January 24th, we will be hosting Ryan O'Connell, the editor for Thought Catalog, who will be giving a moderated talk on everything from the Internet, to sex, to how to deal with the pressures of post-graduate life. We will also be hosting a party in conjunction with CKUT and The McGill Daily, tentatively in early February. Our Fashion section recently shot an editorial shoot, featuring pieces borrowed from a variety of Montreal-based boutiques/shops, that will be posted on the website soon. Finally, our Food section is hoping to hold a sale of their favourite recipes from Leacock's this year.

Graduate and Professional Schools Fair

Over the holiday break, I began to compile a contact information document of all of the extra schools I had invited this year to the Graduate and Professional Schools Fair for my successor. This will mean that I'll be helping them send the invitations out with CaPS the week after elections in March. It's my hope that by sending these invitations out nearly two months earlier than historically done, the AUS will be able to attract the top-tier schools from across the globe, and thus increase the chances of their attendance at the Fair.

Senate Report

Last week on January 18th, I attended Senate with my fellow caucus members. The meeting was centered on a discussion of the Jutras Report's findings and recommendations. I strongly encourage councilors who have not done so to view the livestream, linked below. I have included the report link for those who require additional context.

The Senate discussion also included a point for information on McGill's involvement with the *Quartier d'Innovation* project – a part of the city's ongoing "Montreal 2025" revitalization vision. Questions were raised by student senators, myself included, about the ethics of the project, including: the absence of students in the initial consultation; partnering with corporations with reputations for unethical business practices; gentrification and the possible displacement of low-income families from the area the QI project will be built; corporatization of the education process and its aftereffects on the humanities.

I will be happy to elucidate on any of the points above and on other questions pertaining to that Senate meeting.
