## Freestyle Street Dance Community

#### Austrian School of Economic Association

# MedLIFE McGill- REJECTED

"As a chapter, we have two main goals. First, we hold fundraisers on campus to raise money for the MEDLIFE Fund; created by MEDLIFE to sustain their various development, educational, and health related programs. 100% of all donations to the MEDLIFE Fund goes directly to their projects.

Second, we organize McGill students to go on Mobile Brigades, which are **week-long volunteering trips** to various locations within Ecuador, Panama, and Peru. Students have the opportunity to shadow local doctors, as well as to gain valuable field experience in foreign medicine. A **Mobile Clinic is set up in several stations, and most of them are run solely by students.** These stations include taking patients vital signs, running the pharmacy, teaching children about dental hygiene, and taking patient's histories. While shadowing doctors, students have the opportunity to get hands on experience with diagnostics and patient care, and to learn about the health struggles that exist in these parts of Latin America."

### Reasons for Rejection

- 1) Unconstitutional
  - a. Specifically, in violation of:

VII The Students' Society commits to demonstrating leadership in matters of human rights, social justice and environmental protection. The Society shall be mindful of the **direct and indirect effects** corporations, businesses and organizations have on their social, political, economic, and environmental surroundings.

The committee feels that MedLIFE's actions are unsustainable (1 week long, not recurring), and are harmful to the communities they attempt to serve (eg clinics run solely by untrained undergraduate students). We strongly believe that this group is socially irresponsible and is exploiting vulnerable communities so that McGill undergrads have something to write on their CVs.

#### End Poverty Now-TABLED

"End Poverty Now is a national organization dedicated to relieving poverty on both local and international levels. This vision is supported by the three "pillars" of grassroots projects, education, and InReach. Started by McGill students in 2006, EPN has since spread across Canada, with several chapters in different cities and universities. What we believe makes the McGill chapter of End Poverty Now so unique compared to other clubs and charities is our personal, hands-on approach. The members of the club work closely together in a friendly, motivated environment that paves the way to creative, innovative ideas for volunteering opportunities and fundraisers. We decide what projects – both local and international – we would like to fund, which makes every project close to everyone's heart. Moreover, our hands-on approach not only gives us the opportunity to have a

direct impact on the community but it also enables us to see exactly where the club's money is going and how it is spent."

#### Mandate

- Conduct fundraising for the national organization
- Provide local volunteer opportunities for club members to work hands on to alleviate poverty in their own cities
- Raise awareness of the issue of poverty, both locally and internationally, through various campaigns and events.
- The three major events listed in the application were two dating auctions and a Mexican themed party. The committee struggles to find the connection between dating, dressing up as Mexicans, and the alleviation of poverty. Although some money was raised at these events, the committee feels that ENP is not fulfilling its mandate to raise awareness or to provide local volunteer opportunities. It is also concerned about the small minded nature of such a racialized party and the underlying colonial attitudes that this may indicate.
