<u>SSMU Budget:</u> I have sent out requests for appointments to the relevant individuals to revise the SSMU budget approved by the Legislative Council last semester; the revisions will be included in my next report which will consequently be approved by Council.

Moving forward, I will complete the Financial Plan which is being pushed to the next meeting to ensure it is one-hundred percent accurate and sound; thank you to the Finance Committee for their feedback on the first draft of the plan.

Lastly, I am already scheduling appointments with the relevant individuals in preparation for the 2012 – 2013 fiscal year budget which must be approved by the Legislative Council before the end of the semester.

<u>Financial Transactions:</u> As I mentioned during the last Legislative Council meeting, the financial transactions as per the mandate passed last semester are posted on the SSMU website under the "Fiscal Responsibility" page.

<u>Clubs:</u> I have been meeting with many clubs during office hours to go over funding, the club audit, and fundraising ideas and will continue to provide support as needed.

<u>Services:</u> I have sent all the Services a message to book an appointment to discuss their most up-to-date financials and budget revisions.

### 4. ADMINISTRATIVE COMMITTEES

<u>Finance Committee:</u> Last week, the Finance Committee went over the long-term Financial Plan and we were able to thoroughly go over areas which can be further expanded. The Comptroller is currently assessing the CERF account and will be further providing notes on some of the journal entries; on my end, I will be expanding the explanations for the projected investments to facilitate the users understanding of the Financial Plan.

<u>Financial Ethics Research Committee:</u> The committee will be meeting on February 13, 2012 between 7-8pm to review the Purchasing Policy draft before bringing it forward to the Legislative Council sometime in March. On my end, I will be spending a few hours reviewing the draft for a second time to ensure that the substantive aspects are consistent and accurate.

We will also be looking into investment options that fit the criteria of the recently passed Ethical Investment Policy.

<u>Funding Committee:</u> Firstly, to ensure that we are well within the budgeted figures, I ran an analysis of the funding balances to-date. Of the funds, the Campus Life Fund has been almost dispersed; you can find the figures on the SSMU Funding page. Secondly, the Funding Coordinator continues to process applications, cheque request forms, and responding to e-mails, in addition to organizing the application records of 2011 – 2012.

<u>Operations Management Committee:</u> I will be scheduling a meeting for mid-February given that there is little to discuss this semester and since the Councillors on this Committee also sit on the Student-run Cafe Working Group.
