President's Report to Council

For March 29th, 2012.

The weeks just keep flying by. This is our second to last Council meeting—how did that happen?

Student Democracy and Constituencies

Bylaw Review Committee – The Bylaw Extravaganza continues. Revisions submitted to Council cover nearly every article in Book One and much of Book Three. Book Two requires a complete overhaul, which VP Patel has committed to drafting before he leaves office.

Conflict of Interest Policy – I received confirmation from our legal counsel that he has no further edits to propose to the final draft presented for adoption on tonight's agenda.

Elections – I have been providing administrative assistance to Elections SSMU in regards to the exceptional referendum period. Additionally, I conducted interviews for the new Chief Electoral Officer, who will run the exceptional referendum period due to current CEO Rebecca Tacoma's resignation (which stemmed from her academic commitments).

Judicial Board – Status quo. I have received confirmation from the Chief Justice that they will be proposing internal procedures for ratification at our final Council meeting.

Strategic Summits – VP Patel and Intern Flint Deita hosted our final Strategic Summit of the year regarding the Student-Run Café this past Friday. The summary document of all the strategic summit discussions and action items is in the works (thanks to the Secretary General).

Presidents' Roundtable – I met with the Large Association Caucus and the full Presidents' Roundtable on March 14th.

Relationship with AUS – Following the concerns about the AUS General Assembly and the SSMU Executive's subsequent letter, I participated in the meeting between the SSMU and AUS Executives. Subsequently, AUS President Jade Calver and I met to draft the joint statement which was distributed to the media last week. VP Clare and I also met separately with Councillor Bi.

March 22nd – In the lead up to last week's huge demonstration, I participated in a meeting with various McGill staff members in order to discuss safety and security precautions; liaised with various McGill staff in the days leading up to the March; along with VP Clare, edited the SSMU tips on things to prepare for if protesting and sections of the SSMU strike FAQs; and contributed to SSMU's contingency planning. I participated in the march, and was extremely happy about the turnout and the lack of physical violence.

Student Leader Orientation – I met with folks from the Offices of the Dean of Students, the Deputy Provost, and Student Services to discuss the agenda for the annual orientation

workshop for student association executives (to be held the second week of May). I'm excited by the prospect of a lot more co-presentation by staff and student leaders.

Handbook – I met with VP Fraser and the Communications and Publications Manager to discuss plans for next year's handbook, which is being transferred from the VP C&S portfolio to the President. The bulk of the work will begin once we have hired a content editor.

Long-Term Financial Plan – I participated in a review session to assist VP Patel in moving forward with this document.

Room Booking System – I participated in a training hosted by VP Fraser concerning the new room booking system.

Assorted Events – I attended St Patty's at Gerts, TVM's Fokus Film Festival, and the Haiti Benefit Gala.

McGill Governance & Relations

Board of Governors – I attended the most recent Nominating, Governance, & Ethics Committee and the Board of Governors full meeting. Items in open session include the DPSLL's annual report, remarks by the Chair and the Principal, approval of the new Dentistry institute in Qatar, and further remarks by the Dean of Medicine re the asbestos story.

Senate – I attended Senate, wrote a blog post for Senator's Corner, and participated in the recent Senate Committee on Physical Development meeting.

Lease – VP Clare and I met separately with the Provost, Deputy Provost, and Ms. Campbell regarding this issue. The Lease Committee met again this weekend. We are finally seeing some movement to start to address some of our key concerns.

Deputy Provost – VP Clare and I met with the Deputy Provost concerning various issues, including the Lease, student strikes, March 22nd, and the exceptional referendum period.

Student Life Associate - Status quo. Ian Simmie returns to work this week.

McGill Alumni Association – I attended the MAA's Board Meeting last week. They are doing bylaw revisions too.

Food and Dining Advisory Committee – I attended on last week. Omer and David from the Sustainability Case Competition were guests and discussed the outcomes of the case competition expo.
