- All of the Board of Directors minutes from 2015, 2016, and 2017 have been reviewed by the SSMU General Manager (Ryan Hughes), GM Administrative Assistant (Michal Chernov), and myself.
 - All of the minutes in question have been signed by me and are normally available on the SSMU website for the public to consult.
- **Current goals**
 - (1) working on setting a regular Board of Directors meeting time,
 - (2) making sure that all of the BoD meeting minutes are available to the general public to consult shortly after the meeting (regularly updating BoD documents and board minutes),
 - (3) currently re-starting meetings of Board committees, and lastly,
 - (4) working on a training / orientation for incoming Board members.
