F. Senate: next Senate December 4th

- a. I am currently actively lobbying the University to better their new Research Policy. This involves working with students as well as Professors, and William Foster (Policies and Procedures). Despite what the papers have been saying, I would like to clear up that Professor Foster has not failed. We have reason to believe that he is constrained by higher-ups, not a result of his own doing. Proposed edits would be as follows:

- b. Concerns about attitudes towards students: I am concerned about the approach taken by the University towards the prospect of students disagreeing with the new policy being brought before Senate. A communiqué was sent to all Senators warning them of protesters and there were no less than 10 McGill Security guards at the Senate. I am of the mindset that, when people feel that they are being represented, you don't run into problems. This was the case at Senate. I will be communicating these concerns.
- G. The Controversial Events debate is not over: I have located McGill's current policy on Occasional Events and it is absolutely contradictory. It is not in the best interest of students or the University to not have a clear policy on Occasional Events. Even if this policy says "anything goes", it will be something to point to instead of the situation of uncertainty and limbo dependent on the judgement calls of individual Administrators we find ourselves in right now. I am working on a "post mortem" of the Choose Life event with regards to the University-SSMU relationship.
- H. Course Evaluations Focus Group: Thank you to Councillors Yu and Desrosiers for attending the Course Evaluations Focus Group. We had some valuable discussions and will be making recommendations to the Course Evaluation Advisory.
