Report of Student Equity Committee to SSMU Council February 4th, 2010 Submitted by Jonathan Hann, Equity Commissioner of the SSMU and Chair of Student Equity Committee

The Student Equity Committee is currently addressing 4 items of business within its mandate: Social Justice Days, finalizing the revision of the SSMU Equity Policy, membership, and discussions with Choose Life.

Social Justice Days, which will take place from February 8th to the 17th is expected to be a one of the most diverse, engaging, and insightful weeks ever planned! With panels and discussions on topics ranging from Haiti Relief and Student Priveledge to Olympics issues and Student Opposition to War, there will certainly be content that everyone on campus can relate.

The membership of the Student Equity Committee has grown from six to ten people overnight! We had many qualified candidates to choose from. In the end, Charlotte Burns accepted the Representative for First People, Michelle Olding accepted the Representative for Race and Ethnic Relations, and both Ian Becker and Ryan Thom accepted positions as Members At-Large. A meeting was held on Thursday, January 28th from 3:00 PM to 4:00 PM to orient new members and answer any questions they had. The new members are bright, talented people from all walks of life. They are hardworking and outspoken individuals and we are so lucky to have them. The committee is very thankful to finally have quorum! This will enable us to complete our Equity Policy and move forward in more in-depth and broadly represented discussions with Choose Life. Hopefully within the next two weeks, we will have a complete Equity Policy to bring to council.

Finding a reasonable model within the SSMU in which Choose Life can exist is the ultimate goal in the review of Choose Life. The equity committee has had one more meeting with Choose Life since last report to council. The meeting took place on January 29th at 4:30 pm. Nine out of the ten committee members were able to make it to the meeting.

Just before beginning the meeting, we were interrupted by two councilors who could not understand why our meetings are closed. This was discussed at our last meeting of Council and this interruption came as a surprise. If there are any more questions regarding this topic, I encourage councilors to speak to me personally instead of delaying an equity meeting to do so.

The equity committee first conveyed their disappointment in Choose Life based on the pro-life event that took place on January 28th. Even though this event was hosted by Conservative McGill, the fact that Natalie Fohl is on their is executive is reason enough to believe that Choose Life is using Conservative McGill as a platform to essentially act

as a club. This does not show good faith bargaining or respect the negotiation process we are currently undergoing.

Choose Life expressed their discontent in the lack of expediency the process is taking. However, the equity committee feels that in order to get the most out of this process, it is not the point of the committee to draft a document to just restrict Choose Life so that they can move on and come as close to breaking the restrictions as possible without receiving infractions. We have to create an understanding of all areas of equity before this process ends.

During the last meeting, one item that came up is the contradictory nature of Choose Life's last written agreement:

- 1. "Not showing images of violence without prior warning to viewers.
- 2. Clearly repudiating hate speech and all forms of violence."

Choose Life felt that these statements were not contradictory. Their argument is that they are repudiating the violence that takes place when Women abort their children. They also stated that just because they repudiate violence, doesn't mean they can't show the realities of violence that takes place in the world.

The equity committee is very worried with this statement. Safe spaces are not created through combating violence with other means of violence, physical or otherwise. We are also quite uneasy with the notion that they refer to the images they show as "images of violence." The equity committee ultimately wants to ensure that all future images will be behind closed doors with a viewer discretion warning before entering.

The mandate of Choose Life is very positive. However, it is not good enough to be an active club without completing parts of their mandate. Part of their mandate is to help Women faced with this difficult decision, and so far there has been no evidence that Choose Life has reached out to these Women. The equity committee suggested that if students saw that they were proactive in their mandate, fundraising and reaching out to help Women, instead of just taking a moral standpoint on the issue, the perception of their club would be changed for the better. Choose Life stated that they do not want to be told how to run their club and they thank us for the advice, but they do not care how they are perceived by students. They want a document drafted saying what they can and cannot do, not advice on how to run their club. Equity committee is not confident in the degree to which a bare bones "dos and don'ts" document would be effective without attempting to foster an understanding of equity with Choose Life.

There is concern on the part of the equity committee that Choose Life is disrespecting this process and the committee. They are taking an extremely defensive position on every issue we bring up and it is very hard at this point to find mutual ground. Hopefully, this will change in future meetings.
