**Club applications:** Report to be presented for approval.

**Club Audits:** Success! There have been more submissions than last year. The accounting department is going through them now.

**Club Workshops:** There are 5 workshops this week so I'm hoping to boost attendance. I'll report on how many clubs came to them this year and prepare a list of the groups who will be considered inactive for this year.

**Club Funding:** Here is a breakdown of the applications, compiled by the Funding Coordinator

- o 5/6 Equity Fund applications - \$4,471.00/\$4,517.65
- o 3 Space Fund's - \$6,000.41
- o 9 Green Fund's - \$21,072.48
- o 14 Charity Fund's - \$19,757.74

- o 44 Campus Life Fund's - \$62,165.48
- o 57 Club Fund's - \$82,746.72

**Services Check in Meetings:** I've met with SACOMSS, Organic Campus, Players Theatre and Queer McGill these past two weeks.

**Vandalism:** One of the signs leading up to the second floor was ripped off the wall and broken. Unfortunately, the damages will cost SSMU quite a bit of money in repairs.

**False Fire alarm:** The fire alarm this week was caused by someone who pulled the fire alarm without apparent cause. SSMU will be responsible for paying the fine that was incurred.



**Activities Night Wrap-up:** Currently finalizing the actuals for the event as well as reviewing the coordinator job description. The General Manager and I have been considering hiring a second coordinator to ease the intense workload, especially if we want to institutionalize Rez Activities Night into a yearly event.

Having reflected on the event, the clear difference between Fall and Winter Activities Night was that people were a lot more decided on what they were looking for. As such, the flow was a lot quicker and students went looking for groups they had already heard of and wanted to sign up for. As a result, the workshops were poorly attended and a better strategy for getting people involved is needed to make it a worthwhile addition to Activities Night. On the other hand, despite the cold weather, there were more attendees this year than last Winter Activities Night (though I attribute that more to last year's flood).

**Services Summit:** Starting to look into the logistics of organizing a Services Summit between all of the services. Discussion topics would include service executive transition and institutional memory, a services promo video for Fall2014, co-curricular record beta testing, etc.

**Sound system for the Ballroom:** Delayed, unfortunately...

**Fourth Floor Revamp:** SQ, currently working out the logistics of the clean-up that we are planning for March break.

**Gardens and Grounds Subcommittee:** Had a meeting last week, it was mostly updates on various projects and their progress since the break.

**Committee on Student Services:** A working group was established to discuss the terms of reference for a possible Innovation Fund sub-committee. We have a meeting this Friday to discuss it before the next CSS meeting.

**Interest Group Committee:** Presented is the report that I mentioned last Council but was not ready in time for it to be approved.

**Services Review Committee:** All of the meeting for the rest of the semester have been scheduled. We met on Tuesday and reviewed FYC and MISN's amendments to their constitution. These will come for approval next Council meeting.

**Building Committee:** We allocated the remainder of the Space Fund to various projects and discussed a few topics such as the logistics for the coat check, the installation of a defibrillator near Liquid Nutrition, the cleaning of the 4<sup>th</sup> floor, the pest control situation, storage space for various groups, HVAC replacement, etc
