Clubs, Services & Independent Student Groups

Club Record Consolidation Project

The Interest Group Coordinator and I have gone through all of the club records and extracted the most up-to-date constitutions to be able to refer to them as quickly as possible. We've discovered that a few clubs do not have constitutions, and that many of the ones we do have are old and no longer accurately describe a club's activities or structure. We are requiring that in order to change their signing officers that clubs use executive positions that exist in their current constitutions. Usually, this encourages a club to update their constitution to include current positions that do not exist in their constitutions.

Club Inactivity

At the end of last year, 42 clubs were deemed inactive. If they are not active again this year, they will lose their Club Status. On top of that, 11 clubs have lost their Club Status due to not applying for Full Status before their Interim Status expired.

Office Allocation Timeline

The Recurring Events Allocation is complete. All the groups that applied have been contacted with their approved bookings.

Club Funding

The Funding Period is now open for all of the SSMU Funds. The Club Fund this year is set at 50,000\$. The deadline to apply for funding is October 10th at 11:59PM.

Club Audits

The Winter Audit was completed over the summer and all of the scores have been communicated to the clubs. The average audit score was 3.48/5 which is relatively good, however only 117 groups submitted an audit form, roughly less than half of our clubs.

Club Hub

I am preparing a report for the research that I have done over the summer, and will be presenting at a future Council meeting.

Student Staff

All of the student staff under my portfolio have been hired and trained except for the Culture Shock Coordinator.

Service Representative Elections

Unfortunately, the Services Representative elected last year has resigned due to a conflict of interest. We will be holding by-elections to fill the seat. The Executive Committee acted as the Interest Group Committee over the summer. 6 new clubs were approved over the summer.
