APPENDIX A – Updated CARE Messages

To Milton Parc residents

- The SSMU values the quality of life of Milton Parc and the importance of working co-operatively with the permanent residents to preserve it.
- The SSMU values the rich history of the Milton Parc neighborhood and understands that the high quality of life present in the neighborhood is the result of community activists who have advocated for neighborhood rights for many decades.
- The SSMU recognizes the sometimes disruptive effect and unacceptable behaviour that some McGill undergraduate students have on the Milton Parc community and its permanent residents.
- The SSMU recognizes that some events organized by McGill students may have been highly disruptive to the residents of the Milton Parc neighbourhood, and we apologize for this.
- The SSMU is committed to organizing initiatives that seek to reduce harm in the Milton Parc community during historically disruptive events.
- The SSMU recognizes that students make up a minority of the population in Milton Parc and therefore should not treat it as their own. The SSMU looks for relations to begin with respect, not resentment, and we welcome constructive feedback from residents.
- We recognize the process of studentification that is taking place in the Milton Parc neighbourhood and the necessity to work collaboratively to proactively address its consequences and maintain the quality and diversity of the neighbourhood.
- The SSMU looks forward to working together with the permanent residents of Milton Parc generally, and with the Milton Parc Citizens Committee and other community organizations in a spirit of positive engagement to find solutions to the issues we face collectively.
- We are committed to develop yearly activities that will serve to bring student and permanent resident communities together in an effort to cultivate an enhanced community spirit.
- We endeavour to be accessible and responsive to the permanent residents of Milton Parc.

To students
