The Club's mandate shall be to:


- Inspire and engage students in the political process in order to develop conscientious community leaders capable of confronting mounting global challenges;

The Club Committee recommends the approval of Fit for a Cause due to their score of 25/30 on the Interim Status Approval Rubric.



Events:


- 1. **Vegan Potluck and Meeting and Greet**: "A full evening of food and recipe sharing! Along with these activities, due to the nature of the event, common topics for conversation included reasons for being vegan and discussions of vegan activism, organizing, and future events the club planned on hosting. The large turnout meant that there was a fantastic variety of foods, desserts, and drinks for everyone to enjoy. Since this event was open to vegans, vegetarians, and meat eaters alike, the information sharing was able to reach those within and outside of the vegan community. This event was also attended by McGill and non-McGill students alike, proof that our groups popularity has expanded beyond the limits of the McGill community. This varied turnout also allowed us to recruit new members to the club! Smiles, laughs, and dances were also shared!"
- 2. **Zines for Peace and Justice:** "Members of The Herbivore Society for Peace and Justice set up tables at the aforementioned McGill Rez Cafeterias on the specified dates in order to promote "Meatless Mondays". The volunteers happily informed curious students about the different aspects of veganism and vegetarianism. Topics of discussion included, but were not limited to: environmental factors, animal rights, health, and accessibility and how and where to seek support. These events were information sessions and were used to spread the objective of The Herbivore Society and inform of future club events. Attendees also received free zines."
- 3. **Veganism and Privilege:** "An Open Discussion with Emily Von Euw: A discussion event in the form of an open discussion, featuring four panelists. The position of the panelists was to give an informed introduction to each sub heading of the discussion on privilege and ask questions in order to inspire discussion among all those in attendance. Furthermore, the panelists were available for questioning, as well. Because of the quantity of the turn out, as well as the diversity of those in attendance, the discussion was as inclusive and productive as we wished it would be! The three sub topics discussed were "veganism and gender," "veganism and thin privilege," and "veganism and white privilege." Due to the presence of attendees from different gender and racial identities, as well as folks with different body types, we were able to conduct a discussion wherein people were able to think through ideas about veganism and their own lived experience. Participation was constant and panelists received positive feedback after the event came to a close."

McGill Students Chapter of Canadian Students for Sensible Drug Policy

The Club's mandate shall be to:

- Promote a harm-reduction and health-based approach to drug use;
- Educate students and the surrounding community on the negative effects of drug war policy;
- Highlight the various ways human cultures have used psychoactive compounds throughout history;
- Promote local, national, and international efforts which seek to mitigate the harms of the drug war and implement more just policy approaches;
- Provide an open and non-judgmental forum where students can access reliable drug information;
- Host screenings, invite speakers, and collaborate with local organizations, including compassion clinics and harm reduction groups, in pursuit of the above goals;
- Table regularly to recruit members, provide harm-reduction information, and establish a presence on campus.

Events:

- 1. "Envisioning the Legalization of Cannabis:" The event kicked off with offerings of some snacks and tea, and brief chatting before the screening of a "McGill Talks" video featuring Dr. Mark Ware (director of the Canadian Consortium for the Investigation of Cannabinoids). Following the short film, the audience as well as executive members of the CSSDP McGill Students' Chapter engaged in conversation led by Gonzo Nieto (CSSDP national co-chair). The chat debuted with a short PowerPoint presentation held by Robert Douglas (executive member), introducing our club's mission and purpose. As was done, the audience gathered into a circle to question as well as discuss their presence and purpose at the gathering. Concerns, hopes and enthusiasm were shared over the broad theme of the legalization of Cannabis whereby the talk of safety and policy were rooted.
- 2. The Culture High Film Screening: CSSDP hosted a film screening of The Culture High at The Yellow Door. The documentary brings to light the arguments supporting and opposing the current marijuana laws. The film was followed by a non-judgmental discussion on drug safety, use and policy. The discussion was facilitated by Adam Greenblatt, the Executive Director and Co-Founder for Santé Cannabis, Montreal's first cannabinoid clinic and medical cannabis resource center, and Gonzo Nieto, CSSDP National Co-Chair, and Drug Educator. Tea and cookies were served. The event provided a safe space for people to ask questions and get educated on the subject of marijuana and the existing laws governing its use.
