Issues

- Unemployment & job scarcity
- Exacerbation of inequalities
- Lax enforcement of existing laws
- Elimination of entry-level jobs
- “Foot in door” myth
- Labor exploitation & wage theft

Regulations (QC)

- Quebec Act Respecting Labour Standards
- Unpaid internships (*stages*) illegal except:
 - where part of a program provided by an approved educational institution;
 - where the student is working for a non-profit organization with social or community purposes;
 - where part of a vocational training program.



Regulations (ON)

- Ontario Employment Standards Act
- Unpaid internships illegal except:
 - where part of a program approved by a secondary school board, college, or university;
 - where providing training for certain professions (e.g. architecture, law, public accounting, veterinary science, dentistry, optometry);
 - Where considered a “trainee”.



Regulations (CAD)

- Canada Labour Code
 - No exclusions for students, trainees, or internships
- Policy on Hours of Work
 - Entitled to provincial minimum wage for all “work” (including training)



Suggested Criteria

- [Canadian Association of Career Educators and Employers \(CACEE\)](#)
 - Applied, transferable training
 - Organization receives little benefit (e.g. not replacement employee)
 - Clear learning outcomes & qualified supervision

- Student awareness
- Practicum programs
- Internship courses
- Student groups
- Volunteer research
- Shortage & quality of opportunities
