

POLICY DEVELOPMENT

McGill Policy Against Sexual Violence

- Draft <u>Policy Against Sexual Violence</u> will be presented at Senate this Wednesday, October 19th, including initial proposed revisions & SSMU-PGSS consultation report
- Met with Associate Provost & Dean of Students on Friday, October 14th about recommendations
- Further meetings include Dean of Students (October 17th), Provost & Associate Provost (October 24th), unions & associations (October 28th) & consultants (November 3rd & 4th)

McGill Ad-Hoc Committee to Review the Charter of Student Rights

- SQ Priorities include stronger language on accommodations, disability & intersectionality; ensuring consistency with other policies; improving students' awareness of their rights
- Meeting next Thursday, October 27th to begin revising sections

Unpaid Internships Policy

- Meeting with Arts Internship Office (AIO) this Tuesday, October 18th to discuss mandate
- In response to proposed Senate question, Provost is reviewing current internship postings to ensure legal compliance; results will be shared at November 23rd Senate meeting
- Presenting to Council on background research this Thursday, October 20th; will be followed by draft policy for student consultation in November

McGill Smoking Policy

- Working group drafting smoke-free campus policy based on SSMU <u>Smoking on Campus Policy</u>
