FUND DISTRIBUTION & COMPLIANCE


The Vice President of Finance manages three committees, all departmental budgets, the finances of all 17 services, accounting compliance, financial processes, insurance and club finances

4. ANNUAL BUDGET






OVERVIEW - FINANCE

FINANCE OVERVIEW

The Vice President of Finance has **three major committees** that serves as support functions that directly impact the finances of SSMU. The Finance Committee looks at financial structure and department budgets. Funding Committee looks over funding requests and allocation. Financial Ethics Committee reviews the risk of our financials and ethics.

The VP Finance also sit on various other committees that aren't directly related to finance but require financial supervision

PROBLEM IDENTIFICATION

There are **three main issues** I have come to realize with SSMU. First, the process management of SSMU. Second, the lack of integration and disconnect from business and government. Third, SSMU massive scale is suffering from diseconomies of scale. Many of SSMU processes are not separated from business and student government and needs to be clearly delineated before we restructure it back together.





ORGANIZATIONAL DIAGRAM





OTHER THINGS I HAVE DONE

- Develop an Accounting Guide
- Redeveloped the work flow process for the Funding Committee from scratch
- Revising the Internal Regulations of Finance
- Develop new student life and finance processes for clubs
 - Developing a new student group auditing process
 - Develop and initiate annual workshops to increase financial literacy
- Reduce expenses and make sure everything is in line with the budget approved by Council last year.
