 - Steering Committee discussed the potentially problematic nature of votes by unanimous consent insofar as they may place Councillors in an uncomfortable situation. In accordance with the Standing Rules, the default voting method shall remain an electronic ballot with results posted after the meeting.
 - Steering Committee discussed the length of the previous Legislative Council meeting and has brought forward a motion to specify suggested time limits on debate for each motion and a goal to end Legislative Council meetings no later than 10:00 pm. Steering Committee will also exercise its power to more evenly schedule presentations and debate on motions.
