# 1. SECURITY SERVICES COLLECTIVE PROMOTION COMMITTEE

- **1.1 OVERSIGHT**. The Security Services Collective Promotion Committee shall be a Committee of the Board of Directors.
- **1.2 GENERAL**. The Security Services Collective Promotion Committee shall collaborate with all security related services of the Society to advertise and promote their functions and help them gain more visibility.
- 1.3 RESPONSIBILITIES. The Security Services Collective Promotion Committee shall
- a) Create shared and individual service posters and ensure all McGill buildings and residences have them as well as any external venues the services request;
- b) Set up and create content for giveaways from the services;
- c) Review and handle all sponsorship opportunities for these services;
- d) Register the services to any tabling opportunities they wish (for bake sale & for events such as Discover McGill, Activities Night etc);
- e) Create and manage the social media content for these services on their shared page on Instagram and Facebook;
- f) Reach out to groups on campus to share the services events and important publications to more audiences;
- g) Receive and transfer any collaboration requests from external actors to the services;
- h) Take on any other tasks given by the services (can include postering & tabling)
- i) Hold the Society's Vice-President (Student Life) accountable in communicating and reporting with the the Society's Communications and Publications Manager for any tasks or advice on the committee proceedings and;
- j) Review and make recommendations to the Security Services Collective Promotion Committee's terms of reference at the end of the year.
