The Indigneous Affairs Committee has continued in providing stable and consistent consultation to non-Indigenous partners at both the SSMU and McGIII. Examples include the Indigenous Affairs Commissioners ongoing work with campus-partners in establishing and working towards the designation of "safe spaces" where Indigenous students will be able to smudge with proper ventilation and accessibility.

Ongoing event planning:

Intergenerational Resiliency: Overcoming Trauma, with keynote Cindy Blackstock

- March 2020, to be facilitated in collaboration with the community to integrate Indigenous vendors, Indigenous caterers, and an Indigenous art exhibition on campus.

Long-term Planning and Progression:

The Indigenous Affairs Committee is in the process of advocating for internal reforms which will further empower the Indigenous student community to advocate for greater support systems within both McGill and the SSMU.

These changes include fiscal autonomy, internal reforms to the relationship between Indigenous Affairs and the executive committee, and amending the Indigenous Solidarity Policy in order to facilitate a greater degree of autonomy and allyship from the SSMU.

These changes will facilitate a campaign comparable to last year's #ChangeTheName campaign. Following the successful implementation of such changes, the Indigenous Affairs Commissioner will expand the Indigenous Affairs team by hiring an Indigenous Equity Researcher, and Indigenous Affairs Campaigns Coordinator. Together, these three positions will begin the planning phase for another campaign, which will begin the Winter 2020 Semester. The campaign will be publicly launched in the fall of 2020 to coincide with McGill's bicentennial year, after a period of consultation with Indigenous stakeholders. This will include consultation with Urban Indigenous community partners, Kanienkehá:ke, and stakeholders within the McGill Indigenous community.

Broad discussions we hope to facilitate include the creation of an Indigenous studies major, the expansion of services offered by the First Peoples' House, the facilitation and promotion of Indigenous recruitment pathways, and the further implementation of Indigenous specific financial aid.
