# Background and Rationale

The UGE has had discretionary funding in the recent past which lapsed in 2016. The restoration of discretionary funding the restoration of discretionary funding needs to be approved with the general membership for financial transparency.

Discretionary funding is funding given to McGill and Montreal community organizations and individuals who align with the UGE's anti-oppressive mandate. Examples of discretionary funding may include but are not limited to financial contribution to events such as Culture Shock and Lavendar Grad, support for the launch of a book of queer poetry, and other initiatives in line with the UGE mandate.

Given that the UGE has been able to do this effectively in the past, and is under no obligation to give out discretionary funding, the risk to operations is negligible.		
	Sustainability Considerations	Environmental: None/not relevant. Social: This would provide an additional source of funding for Campus and Community Groups aligned with the mandate of the UGE.
