2. Land Acknowledgement

The SSMU acknowledges that McGill University is situated on the traditional territory of the Haudenosaunee and Anishinaabe nations, a place which has long served as a site of meeting and exchange amongst Indigenous peoples. The SSMU recognizes and respects these nations as the traditional custodians of the land and water on which it is located.

Director Lametti asks if the Executive could provide more details about the communique against proposed changes to the PEQ (Programme de l'expérience québécoise) approved at the July 2nd, 2020 meeting. VP External states that this is not a SSMU communique, it is a motion to sign on to a communique shared with the SSMU by community organizations. It is an open letter brought by

labour unions, worker organizations and community organizations opposing the proposed reforms to the PEQ. VP External offers to find a copy of the letter to review the wording if Director Lametti wishes. Director Lametti states that they would like to be able to review the document but have no need to do so during a board meeting.

Director Bhutkar asks if the hiring of the OER (Open Educational Resources) Coordinator is part of the SSMU Academic Support Services fee. Director Frizzle replies that this position is part of a project initiated by the former VP University Affairs. Director Frizzle says that they are not completely sure about the overlap between each program. The goal of the OER project is to replace textbooks and course packs with free online resources. So far, they have completed one economics and one physics course and are moving onto other entry level science courses. They are not directly related, but fulfill a similar mandate.
