Hey folks! My name is Elif and I am one of the Engineering Representatives for this year!

## **Engineering Affairs**

- Passed the motion regarding the Council Restructure Plan.
  - SSMU Reps and Senators will lose their right to vote, as they are not meant to represent a particular constituency.
  - We will have less people in council (more dense council)
  - Redefining the EUS Council and Board of Governors relationship.
- Passed a motion regarding canceling all gatherings, other than those approved by McGill Faculty Access Protocols, under the purview of the EUS and its Departmental Societies until November.
- Had Dean Nicell in our meeting to voice the concerns and updates on remote learning as well as accessibility to softwares and medias necessary for Departments, Design Teams, and Committees.
- Had the Board of Governors presentation:
  - Members at Large are chosen.
  - Council member selections (2 people) will be next council to finalize this year's Board.
  - Fund approvals, OAP did not happen, so EUS has a smaller budget this year.
- EUS Groups' Fall Budgets are submitted and approved.
- EUS Involvement Restriction Committee Members at Large Selection were made, Committee is formed, chaired by EUS Equity Commissioners, Elif Kurkcu and Yassaman Bassiri.
- Funding Committee Members at Large are selected.
- MEC is on November 7th-8th, it is the McGill Engineering Competition where we choose a delegation to compete at Quebec Engineering Competition, which is canceled this year so we are going to send the team to Canadian Engineering Competition directly. (External Relations)
- All-Faculty Involvement Restriction Policy is under review by our lawyer before we sign onto it.
- We are restructuring some sub committees under the Executive Members.

- EUS Council Meetings will take place bi-weekly and remain remote for the time being.
  - The next EUS Council shall take place on October 28th, 2020, 6 PM EST.
  - No motions are on the table as of now.
