- Preliminary report was approved by BACoN at the December 10 meeting
 - Three front-runners selected currently waiting on consent from the nominees
 - To be presented to Council for generative discussion following final consultations

Equity Infrastructure

- BAC is actively transitioning from Interim Chair to the Black Affairs Committee
- Accessibility Policy was revised and submitted for reapproval
 - Presented as a Notice of Motion for January 14, 2020
 - Hiring process for Accessibility Commissioner ongoing
- Meeting with the Equity Commissioners biweekly to revise the Equity Policy
- Working with Queer McGill and the Union for Gender Empowerment to hire and Gender and Sexuality Commissioner

- Message of Support for Survivors of Gendered and Sexual Violence drafted and released on December 19, 2020
