University Affairs & Research

Senate and Committee Activity

- University Student Assessment Policy Work Group met on February 15, 2021
 - Discussed "must-pass" assessments and exam accommodations
 - Next meeting on March 8, 2021
- CSS Mandate Revision Working Group met on February 11 and 23, 2021
 - First draft of the revised Terms of Reference has been completed
 - Planned consultations with the Deputy Provost (Student Life and Learning), Executive Director of Student Services, and CSS Faculty Co-Chair

Board Ad-hoc Committee on Naming (BACoN)

- Met on February 19, 2021 to discuss consultations made with the Deputy Provost (Student Life and Learning) and the Vice-Principal (University Advancement)
 - New opportunities and necessary setbacks were deliberated

Equity Infrastructure

- Began onboarding the Gender and Sexuality Commissioner on February 12, 2021
- Met with the new Student Services EDI Advisor on February 16, 2021
- Equity Policy revisions ongoing
 - Black Affairs Commissioner and Gender and Sexuality Commissioner were added to the Revision Working Group
 - Revised Definitions, the Equity Complaints Committee, Accountability and Reporting, and began revising Complaints Procedures on February 23, 2021
- Attended a Judicial Board Hearing on the 2018 Reference re: Applicability to Services
- Working with the Indigenous Affairs Commissioner to restructure the portfolio
 - Continuing work on a Master Plan to expand the portfolio
 - Finalizing a job description for an "Indigenous Affairs Secretary-General"
