#### Issue

Since this document was last amended in 2019, Student group operations and needs have shifted. This motion seeks to adopt amendments to the *Internal Regulations of Student Groups* to reflect student group current operations.

### Background and Rationale

Per the SSMU Constitution the Society shall serve as an umbrella organization to coordinate and support the student groups that make up civic life in the McGill community, while providing services to strengthen the educational, cultural, environmental, political, and social conditions of our Members. The *Internal Regulations of Student Groups* serve as a structural backbone in order for student groups to operate under the SSMU. This document gives clear indication on interpretation, administration, & accreditation of student groups.


