### Background and Rationale

SSMU, MCSS, PGSS, and McGill University have made commitments to supporting a culture of sustainability, as exemplified by the co-creation and operation of the Sustainability Projects Fund (SPF) in Winter 2010. SPF is co-funded by students (50%) and the University (50%) and has funded over 300 projects to date totaling over eleven million dollars. The previous SPF referendum took place in 2017-2018, and passed with the following percentage of students in favor of contributing \$0.55 per credit (up to 15 credits) to the Fund: SSMU (89%), PGSS (74%), and MCSS (98%). Maintaining the fee of \$0.55 per credit (up to 15 credits) will allow the fund to continue operating at its current level of approximately \$1 million per year over the next five years, from 2023 to 2028.

# Alignment with Mission

The fund's mandate is to build a culture of sustainability on campus through the development and seed-funding of interdisciplinary projects, and any student/staff/faculty can apply for money to fund their sustainability project. This aligns with SSMU's mission of achieving sustainable practices



by balancing and integrating economic, social, and environmental considerations in the way it acts, and by having staff and students collaborate to achieve this balance. It also provides students with real world opportunities to develop their knowledge on sustainable projects through volunteering and the ambassador program. The SPF has trained over 7,500 people and involved more than 4,500 volunteers.

#### Consultations Completed This question has been discussed with and reviewed by the SSMU President, the SSMU Vice-President University Affairs, the SSMU Vice-President (Finance), the SSMU Vice-President (External Affairs), and the SSMU Executive Committee, the SSMU Sustainability Commissioners, the SSMU Policy and Advocacy Coordinator, the Sustainability Manager at McGill Office of Sustainability (MOOS) and the Deputy-Provost of Student Life and Learning, ESG McGil, and a beneficiary of SPF.

# Risk Factors and Resource Implications

Failure to renew SPF would result in the fund ceasing to exist, ending its support for current and future Sustainability Projects. Failure to renew from SSMU will also cancel the collaborative fund for MCSS and PGSS. Consultation with SSMU VP Finance revealed no financial risk from SSMU for either accepting or denying this renewal.

## Sustainability Considerations

Since its creation in 2010, the SPF has allocated over \$10.8 million in funding and has approved 294 projects, which have yielded dramatic and lasting improvements to the social, economic, and environmental dimensions of McGill's sustainability performance. It is also one of the largest of its kind in North America, making McGill SSMU a leader in sustainability at an international level<sup>1</sup>. Project applications are accepted from any current SSMU, MCSS, PGSS students, and McGill academic staff and administrative staff.

# Impact of Decision and Next Steps

McGill University is committed to match the student contribution dollar for dollar – between Fall 2023 and Winter 2028. Maintaining the fee of \$0.55 per credit (up to 15 credits) will allow the fund to continue operating at its current level of approximately \$1 million per year over the next five years, from 2023 to 2028.

This fee renewal would support future Sustainability initiatives but not renewing would result in the abolishment of the SPF entirely.

# Motion or Resolution for Approval

**Whereas**, It is acknowledged that the definition of sustainability within SSMU is not reflected by the current acting decision within the SPF Governance Council to exclude considering applications of social and economic sustainability focused-projects.

**Whereas**, it is important to recognize that the positive impacts of the projects funded by the SPF do not outweigh the harm caused by McGill's refusal to divest.

Be it resolved that the Legislative Council approve the following question for the Fall 2022 Referendum period:

**Whereas** maintaining the fee of \$0.55 per credit (up to 15 credits) will allow the fund to continue operating at its current level of approximately \$1 million per year over the next five (5) years, from 2023 to 2028;

**Whereas** further information about the SPF is available at <u>www.mcgill.ca/sustainability/spf</u>, including application process and criteria, funded projects, annual reports, and other relevant documentation;

**Whereas** a "No" result for the SSMU, MCSS, and/or PGSS referendum would abolish the SPF entirely;

**Whereas** McGill University is committed to match the student contribution dollar for dollar – between Fall 2023 and Winter 2028;

> Be it further resolved, that the SSMU Legislative Council adopts the actionable aspects of this question, and recommends the ratification of this referendum question to the Elections SSMU and Board of Directors, and that any grammatical or legal changes necessary do not need the re-approval of the Legislative Council.
