Sustainability Considerations	This motion is necessary to ensure the sustainability of the Society's finances and status as a not-for-profit.
Impact of Decision and Next Steps	Should this motion pass, FL Fuller Landau LLP shall be instated as the Auditor for the Society during the 2023 Fiscal Year.
