BACKGROUND

Haven, a campus safety app developed by the Haven Safe Technology Corporation, is a mobile application used by thousands of students in Canada to quickly connect with loved ones and the police in emergency situations. With Haven, students have a 'Swiss Army Knife' of safety on them at all times, perfect for when they feel uneasy or need help immediately. University of Toronto Computer Engineering student Nelson Lee created Haven in 2020 after hearing about a friend's on-campus sexual assault story.

The Students' Society of McGill University is the official student's union for students at McGill University, located on Haudenosaunee and Anishinaabe, traditional territories.

PURPOSE

This MOU will enable Students' Society of McGill University to establish an enhanced campus safety presence with the aid of the Haven Safe Technology Corporation's 'Haven – Safety Alert & Locator' app.

The goal of the Haven Safe Technology Corporation for this MOU and partnership with the Students' Society of McGill University is to increase the reach of its mobile safety application technology for students in the McGill community. The Haven Safe Technology Corporation's goals of 'making the world a safer place' is achieved by having more students use its revolutionary campus safety app, Haven.

The goal of the Students' Society of McGill University for this MOU and partnership with the Haven Safe Technology Corporation is to fully utilize technology to better provide intervention and prevention-related services for the McGill student body. The Haven app will allow the Students' Society of McGill University prevent incidents and better support students of critical incidents while gaining key insights into on-campus safety metrics.

AGREED UPON ACTIVITIES

- 1. The Haven Safe Technology Corporation and the Students' Society of McGill University will actively work to establish the contents of this MOU into a binding contract approved by each respective Executive Committee member by the start of February 2023
- 2. The Haven Safe Technology Corporation and the Students' Society of McGill University will engage in a formal partnership and collaboration effort in good faith, trust, and mutual respect
- 3. The Haven Safe Technology Corporation and the Students' Society of McGill University will work together to promote an atmosphere of collaboration and partnership that will maintain, safeguard, and sustain sound financial, managerial, and administrative commitments from both the Haven Safe Technology Corporation and the Students' Society of McGill University
- 4. The Haven Safe Technology Corporation will license its Haven app to the Students' Society of McGill University until April 31, 2023, for \$0.00 + tax

- a. The Haven Safe Technology Corporation will provide 24,000 McGill seats through a special Organization Code for students at McGill University
- b. The Haven Safe Technology Corporation will incorporate McGill University informational resources into the Haven app
- c. The Haven Safe Technology Corporation will guarantee same-day support for McGill students via email at support@havensafe.co
- d. The Students' Society of McGill University can request for data related to the location and status of a student in cases where the Students' Society of McGill University deems the student at risk
- 5. [Omitted Until the Implementation of a Paid Plan] The Haven Safe Technology Corporation will work with the Students' Society of McGill University to design its customized safety information cards, which is due within 2 weeks of the signage of the MOU
 - a. The Haven Safe Technology Corporation can print and deliver coloured glossed double-sided safety information cards at an additional cost of \$0.20 + tax/card
- 6. [Omitted Until the Implementation of a Paid Plan] The Haven Safe Technology
 Corporation will work with the Students' Society of McGill University to design a
 customized safety orientation event for incoming students, which is due within 2 weeks
 of the signage of the MOU
- 7. [Omitted Until the Implementation of a Paid Plan] The Haven Safe Technology
 Corporation will provide the Students' Society of McGill University a safety information
 packet for Students' Society of McGill University staff, which is due within 1 month of
 the signage of the MOU
- 8. The Haven Safe Technology Corporation will present an annual report to the Students' Society of McGill University detailing important key metrics and Haven's performance at McGill in April 2023
- 9. The Students' Society of McGill University can opt-in to Haven Safe Technology Corporation's consulting services surrounding a Rideshare Collaboration program at an additional cost of \$749.00 + tax per year
- 10. The Student's Society of McGill University will have the option to pay a lump sum of \$0.00 + tax by February 1, 2023, or \$0.00 + tax at the start of each month starting on February 1, 2023, for the licensing of Haven Safe Technology Corporation's Haven app
- 11. The Haven Safe Technology Corporation and the Students' Society of McGill University will negotiate in April 2023 with the outgoing and incoming Executive Team about a renewal of the partnership and services provided by the Haven Safe Technology Corporation
 - a. If the outgoing and incoming Executive Team wants to renew the partnership and services provided by the Haven Safe Technology Corporation, the Students' Society of McGill University will spend Summer 2023 acquiring sufficient funding within the Annual Operating Budget for the partnership with the Haven Safe Technology Corporation, or will spend Fall 2023 implementing a Fee Referendum to fund the services provided by the Haven Safe Technology Corporation for 2024, if passed

REPORTING

The Haven Safe Technology Corporation will detail the work it has accomplished with regards to the goals of the MOU on a monthly basis to Kerry Yang and Coco Jie Wang via email or video conferencing.

The Haven Safe Technology Corporation will undergo an annual accounting audit from a Chartered Professional Accountant and technological audit from a third-party technical consultant to maintain utmost data privacy standards.

By April 1, 2023, the Students' Society of McGill University shall have decided if it wants to renew the partnership and services provided by the Haven Safe Technology Corporation and acquired the funding requested by the Haven Safe Technology from the Board of Directors.

DURATION

This MOU is at-will and may be modified by mutual consent of authorized officials from the Haven Safe Technology Corporation or the Students' Society of McGill University. This MOU shall become effective upon signature by the authorized officials from the Haven Safe Technology Corporation or the Students' Society of McGill University and will remain in effect until modified or terminated by any one of the partners by mutual consent. In the absence of mutual agreement by the authorized officials from Haven Safe Technology Corporation or the Students' Society of McGill University, this MOU shall end on May 1, 2023.
