# SSMU BOARD OF DIRECTORS PUBLIC MINUTES

# April 13, 2023

The Board of Directors meeting of the Students' Society of McGill University (SSMU) will be held by teleconference and in the SSMU Boardroom on Thursday, April 13, 2023 at 18:00.

1. Call to Order: **18:12** 

The Chair calls the meeting to order at 18:12.

2. Land Acknowledgement

The Chair presents the Land Acknowledgement.

The SSMU acknowledges that McGill University is situated on the traditional and unceded territory of the Anishinaabeg and Haudenosaunee nations. The SSMU recognizes and respects these nations as the true and constant custodians of the lands and waters on which we meet today. Further, the SSMU commits to and respects the traditional laws and customs of these territories.

3. Attendance

Director Wan asks the Chair to fix his audio.

The Chair takes attendance. He notes that Officers Pizarro, Williams, Koulibaly and Director Wright are absent.

Director Yang presents the Executive Committee Public Report. He states that new job descriptions were created and hirings were done. Various expenses were taken care of, and services were supported with hirings and preparing for the summer and next year. They also reviewed a few motions.

Seeing no opposition, the Executive Committee Public Report is ratified.

The Chair answers no, they voted to discuss them by block.

Director Masny presents the Legislative Council motions. They state that they will adopt the masterplan for surveillance and doxxing, implement the Food Security Policy and the Francisation

Plan, and change the Internal Regulations of Finance so that there is a plan to use the money from the Black Equity Fund. The Indigenous Equity Fund's allocation will be changed, and changes will be made to make education more accessible. The Mental Health Plan will be adopted, and the Clubs Committee Report and the Services Review Committee reports must be approved. The Services Review Committee evaluated the SSMU services' performance this year.

Director Wan motions to approve Motions 7.a-d and 7.f-i by unanimous consent.

Director Masny seconds this motion.

Seeing no opposition, the Chair entertains a vote by unanimous consent.

Seeing no opposition, Motions 7.a-d and 7.f-i are ratified.
