1. Committee Mandate, Composition, and Membership

2. Summary of Application Cycle

In August 2023, the Nominating Committee was tasked with the hiring of four (4) Board Members-at-large, five (5) Judicial Board Members, one (1) Board International Student Representative and four (4) Nominating Committee Members-at-large.

For the **Board Members-at-large**, applications were opened on August 21, 2023 and closed on September 29, 2023. A total of 1 individual application was received. An invitation to interview as well as a list of available times were sent out on the morning of October 1. The candidate was interviewed on October 7. The interview was conducted by the Parliamentarian remotely via Zoom and recorded, after which one Director of the Nominating Committee watched the recording asynchronously.

For the **Judicial Board Members**, applications were opened on August 21, 2023 and closed on September 29, 2023. A total of 2 individual applications were received. Invitations to interview as well as a list of available times were sent out on the morning of October 1. One candidate was interviewed on October 6 and the other on October 7. Both interviews were conducted remotely via Zoom. One interview was conducted by the Parliamentarian and one Director of the Nominating Committee, and the other was conducted by the Parliamentarian and recorded, after which one Director of the Nominating Committee watched the recording asynchronously.

For the **International Student Representative**, applications were opened on August 21, 2023 and closed on September 29, 2023. A total of 1 individual application was received. An invitation to interview as well as a list of available times were sent out on the morning of September 12. The candidate was interviewed on September 22. The interview was conducted by the Parliamentarian and two Directors of the Nominating Committee remotely via Zoom.

For the **Nominating Committee Members-at-large**, applications were opened on August 21, 2023 and closed on September 29, 2023. A total of 3 individual applications were received. Two applicants were not SSMU members and thus deemed ineligible for the position. An invitation to interview as well as a list of available times were sent out on the morning of October 1. The candidate was interviewed on October 12. The interview was conducted by the Parliamentarian and one Director of the Nominating Committee remotely via Zoom.

Following the conclusion of the interview process the Nominating Committee voted on its nominations for each position at its October 12 meeting. These nominations are not binding on the Board and as such the Board has the right to choose any candidate for the position. Presented in this report are 2 shortlisted candidates for Judicial Board Member, 1 shortlisted candidate for Board Member-at-large, as well as 1 shortlisted candidate for Nominating Committee Member-at-large. No letters of rejection or nomination will be sent to candidates until the Board has approved a candidate to fill each position.
