

Winter 2024 Elections Report

Presented to Legislative Council: April 18, 2024

2024 Executive Elections

- 4306 members voted for a total of 19.1% (up from 16.7% last year)
 - Extended campaign/polling period in comparison from last year.
- 2 out of 7 position **did not have candidates**, while only 2 of the 5 positions that appeared in the ballot were contested
 - Even less candidates and contested positions than last year
- Promoted
 - Online, across Instagram and Facebook
 - Through campaign chairs


For the Future - Issues with turnout and voter apathy

- *Very* high abstention and no rates

As the Executive Election and the Winter Referendum were on different ballots, participation went up while abstentionism didn't increase.

Winter 2024 Referendum

- 4332 overall votes cast, with a total turnout of 19.2% (From 16.7% in previous year)
- Many questions: 19 questions: 18 fee questions, 1 plebiscite question
- Questions passed:
 - Queer Equity Support Fee Increase (53.6% yes)
 - SSMU Walksafe Fee Increase (65.9% yes)
 - Black Students' Network Service Fee Increase (61.2% yes)
 - (1) Legal Information Clinic Fee Renewal (72.0% yes)
 - (2) Legal Information Clinic Fee Increase (59.4% yes)
 - Club Fee Increase (52.3% yes)
 - (1) Campus Life Fee Renewal (60.0% yes)
 - (2) Campus Life Fee Increase (50.2% yes)
 - Student Academic Support Services Fee Increase (62.6% yes)

Questions passed (continued):

- Arab Student Network Fee Increase (56.1% yes)
- Library Improvement Fund Fee Renewal (67.9% yes)
- keep.meSAFE Fee Renewal (64.4% yes)
- Creation of Student Rights Fee and Fund (58.5% yes)
- Nomination of Auditor for 2024 Fiscal Year Referendum Question (71.4% yes)
- Student-initiated question: Mustbus Opt-Outable Fee Increase(51.1% yes)
- Student-initiated question: Student Support Fee (57.6% yes)


Questions Failed:

- SSMU Membership Fee Increase (58.3% no)
- Referral Services Fee Increase (54.6% no)
- Reinstatement of First-Year Fee (51.9% no)

Electoral Violations.

- 4 Candidates were accused of running a slate campaign which is strictly prohibited by the internal regulations.
- An investigation was conducted and two candidates were found responsible and appropriate sanctions were imposed on the campaigns.

Other Issues:

- Unclarity of regulations for online campaigning.
- Unclarity of space permitted to be used for campaigning.

Issues

- Too many referendum questions
- Many uncontested candidates
- Low voter engagement and turnout
- Odd transition period between departure of previous CEO and training of current CEO.
- Lack of norms and regulations for online campaigning.

Potential Solutions

- Changes to the Internal Regulations
- More work on in-person initiatives
- Dividing referendum questions into different referendums;
- having ISG-related questions in independent ballots.

Proposed IR Changes

Preparation of a motion to be presented in Fall 2024 concerning

- Establishment of online campaign regulations,
- Adjustment of outdated norms,

Among other things.
