## Motion or Resolution for Approval

An ad-hoc Committee on negotiating the Memorandum of Agreement between SSMU and McGill University is established, with VP University Affairs and President as co-chair. The Committee is charged with the following responsibilities:

- Consulting with SSMU members to ascertain their interests and desires in a relationship with McGill
- Consulting with the General Manager on how to protect SSMU's operations
- Negotiating the Memorandum of Agreement with McGill University
- Exploring alternate possibilities of a relationship between SSMU and McGill
- Informing the SSMU Board of Directors about the progress and strategy of negotiations upon request
- Bringing a proposed Memorandum of Agreement, or alternate course of action, to the Board for approval no later than February 1 2025

Members are admitted by majority vote of the committee. Members must include a non-executive director and a member-at-large. Quorum shall be a majority of the membership. The committee is dissolved after bringing its proposal to Board.
