Issue		Several committees of the Board have not been staffed properly or functioning in any capacity. The SSMU BoD should be focused on the financial, legal, operational, and long-term health of the Society. The Board must mandate leadership from the executive and staffing teams to prioritize the functionality of these committees, so the Board can focus on issues critical to the Society.		
Background and Rationale		Several SSMU committees such as HR and BOMCOM have not been staffed or active for a significant amount of time. As a result, the Board receives motions directly from executives and the GM on these issues. It is advantageous for the Board to avoid spending time on these issues and to instead focus on high-level decision-making for the society. Examples of some of these motions include 1) Paying for security cameras [BOMCOM], 2) Paying for kitchen equipment [BOMCOM], 3) Deciding on a student service contract - Grammarly [FINANCE], etc.		
Alignment with Mission		The SSMU BoD is focused on the legal, financial, operational, and long-term health of the Society. This motion helps the Board better focus on these things.

Lastly, all committees should have a clear executive or permanent staff lead. This should be captured in the committee terms of reference for all existing and new committees of the board.
