Issue		The proposed Gender Support Fee would serve to cover the costs of gender-related healthcare and support services provided through StudentCare.		
Background and Rationale		StudentCare is the intermediary company through which SSMU provides students with several services including the Health and Dental Insurance plans. Throughout recent years, the services offered through StudentCare have expanded beyond the Health and Dental care to products such as legal services, virtual health care, mental health, and gender-affirming care. In order to provide these additional services in a way that is financially sustainable in the long term, each must be funded by a designated fee. Currently, the gender-affirming care plan does not have a fee associated with it. The proposed fee corresponding to this plan would be opt-outable, ensuring that SSMU members will have the option to decide whether they wish to pay for the service or not.

This fee is opt-outable, which mitigates the potential risk of posing an additional financial burden to SSMU members.

Sustainability Considerations The financial sustainability of the StudentCare plan in question depends on this fee.

Impact of Decision and Next Steps

Impact of Decision:

Should this motion and the subsequent referendum question be adopted, the Gender Support Fee would be: \$9.93 per semester for full-time students, and part-time students.

Next Steps:

If approved by the Legislative Council, the referendum question will be forwarded to Elections SSMU to be included in the Fall 2024 Referendum.

Motion or Resolution for Approval Be it resolved that the Legislative Council approve the following question for the Fall 2024 referendum period:

"Do you agree to the creation of the opt-outable Gender Support Resources Fee, which would be billed as \$9.93 per semester per student for both full-time and part-time students, beginning in the Winter of 2025 and ending in the Fall of 2029 (inclusive), and excluding the Summer semester, with the understanding that a majority 'no' vote will result in the fee not being created?"
