## Background and Rationale

The Musician's Collective fee was created in 2016 following its approval at the Fall 2016 Referendum. The Musicians Collective (MC) is a volunteer-run organization that has provided a public "jam space" within the SSMU building for all registered McGill students who pay the \$0.10 fee, to book free of charge, provides a network of musicians to facilitate music making at all levels and offers instrument rentals. It also coordinates and promotes performance opportunities for bands and ensembles. The fee is necessary for the upkeep of the jam room, the gear we offer, and creating performance opportunities for the McGill student community.

The Musician's Collective is a SSMU Service that provides valuable resources and a community for students who want to make music or are interested in music. The SSMU, as per its mission to provide services to strengthen the educational, cultural, environmental, political, and social conditions of our Members, should actively work to strengthen the capacity of our service.

#### **Notes on Musician's Collective Spending**

The Collective has dedicated all funding to the betterment of student spaces and the fostering of musical community. In the above budget tracking actual spending from the 2024-2025 school year, you will note that expenses were managed responsibly and kept well within our budget at \$3,074.32.

Of this sum, \$2,377.51 was spent directly on equipment to improve the jam room, a space accessible to all students.

\$237.60 was spent on food & beverages given out to attendees of our free open mic nights \$55.87 was spent on equipment transportation, moving instruments, amps etc. to venues hosting student bands and open to all students.

\$403.36 was spent on a team-building/semester planning event involving volunteers and executives. All funds were allocated to provide meaningful support to the student body. The engagement we've generated at our shows and in the jam room reflects this dedication.
