# Who is Elections SSMU?

---

- Independent and neutral body responsible for administering and overseeing all SSMU elections and referenda. This includes:
  - First Year Council Elections
  - Fall Referendum
  - Winter Referendum and Executive Elections
  - Ratification of General Online Assemblies
- Ensuring fairness, transparency, and compliance with SSMU's Internal Regulations and Constitution.
- Handling complaints, disqualifications, and violations related to election rules.
- But most importantly, encourage participation among SSMU members and reduce barriers to voting.

# President

---

The President shall exercise the following powers and perform the following duties: to be the chief officer and chief spokesperson of the Society; to ensure the long- term integrity of the Society; to enforce the Constitution and Internal Regulations of the Society and ensure the maintenance of the governance documents; to chair and coordinate the activities of the Executive Committee; to manage the Society's human resources; to call meetings of and set the agenda for the Legislative Council and the Board of Directors; to manage relations between the Society and the administration of McGill University; and to represent the Members on the University Senate and Board of Governors.the Board of Directors; to manage relations between the Society and the administration of McGill University; and to represent the Members on the University Senate and Board of Governors.

# **Vice President (Clubs & Services)**

---

The Vice-President (Clubs and Services) shall exercise the following powers and perform the following duties: to manage relations between the Society and its clubs and services; to maintain relations between the Society and independent student groups; to coordinate events, programming, and resources to support the Society's student groups; to manage the Society's mental health initiatives; and to liaise and collaborate with University staff from Student Services.

# Vice President (Internal Affairs)

---

The Vice-President (Internal Affairs) shall exercise the following powers and perform the following duties: to engage in regular consultation with the Society's Members; to coordinate the Society's relations with faculty, school, and other student associations, and to facilitate communication among these groups; to coordinate events, programming, and services for first year students; to manage the programming of activities and events of the Society; to oversee the production of the Society's publications; to operationalize the Society's commitment to environmental sustainability and physical accessibility; and to manage the Society's communications and student engagement strategy.

# **Vice President (University Affairs)**

---

The Vice-President (University Affairs) shall exercise the following powers and perform the following duties: to represent the members of the Society on the University Senate; to coordinate the activities of the Senate Caucus; to maintain relations between the Society and all levels of the University, with the exception

# Vice President (External Affairs)

---

The Vice-President (External Affairs) shall exercise the following powers and perform the following duties: to represent the Society and communicate positions and Policy taken by the Society to external bodies and agencies; to lobby federal, provincial, and municipal governments to further the objectives, goals and Policy of the Society; to mobilize students on positions and Policy of the Society and assist in the coordination of student-run political campaigns; to develop Policy regarding initiatives in the Montreal community; to communicate to the Board of Directors relevant external issues which may significantly affect the Society; to coordinate the Society's Indigenous solidarity efforts; to operationalize the Society's commitment to the francophone community; and to attend meetings of relevant local, provincial, national or international student groups.

# Nomination Step by Step

---

- 1. Make sure you are eligible.**
- 2. Complete the nomination form which includes meeting with incumbent.**
- 3. Wait for approval from Elections SSMU.**
- 4. Collect signatures from a Google Form.**
- 5. Elections SSMU verifies whether the signatures meet the requirement, then confirms your candidacy.**

ALL STEPS NEED TO BE DONE BY:

**Thursday, February 12, 2026 @ 11:59 PM**

**NO EXCEPTIONS!** So start early.

# Make sure you are eligible

# Eligibility requirements

---

In order to be eligible, you must:

- Be an SSMU member. All students registered at McGill University shall be Members, except for the following (SSMU Constitution 5.1):
  - students registered in the Faculty of Agricultural and Environmental Sciences;
  - students registered at the Centre for Continuing Education;
  - students registered in graduate programs; and
  - students who are also full-time members of the teaching staff.
- Be registered at McGill at McGill for at least 18 consecutive months (excluding authorized leaves of absence for up to 4 months) with no fewer than 18 credits prior to their initial election. (Memorandum of Agreement 14.4)  
**Essentially, you must have been enrolled since Fall 2024.**
- Be eligible to work in Canada and maintain their eligibility to work in Canada throughout your term of office.
- Not be otherwise disqualified from holding office under section 10.2 of the SSMU Constitution, including but not limited to being under the age of majority, subject to a regime of protective supervision, recognized by a court as having lost the capacity to reason, or being bankrupt, having suspended payments, or having made arrangements with creditors.

# Getting Signatures

# Requirements

---

- 100 signatures
- At least 1 faculty
- None of the faculties or schools should represent >35% of the signatures
  - Applies to ALL signatures, not just the first 100.
  - If you have more than 100 signatures but a certain faculty is overrepresented, you should gather more signatures from other faculties to offset the overrepresentation
  - You might want to include extra signatures to ensure all of the required ones are valid.
- Please make sure they are SSMU members, and not PGSS or MCSS. Those signatures will not count.

# Campaigning

---

- All candidates must attend the **Candidates' Meeting**, which covers the campaigning rules and answer your questions. This meeting will take place **February 23rd, 2026 at 6:00PM**.
- Please contact Elections SSMU ASAP if you cannot make it to this meeting due to an unavoidable conflict (for e.g. an exam). Those who do not attend this meeting without notice will be sanctioned.
- **You must attend the Candidates' Meeting in order to campaign.**
- Other SSMU members can campaign for you - but you must submit a list of members before you start campaigning, more information to be given during the meeting.
- You are limited to **\$300** of fair market value.

# Pensketches

---

All candidates have the right to pen a brief outline about themselves, their qualifications and the ideas that they will bring to the position being sought. Video pensketches may also be used, with consent from candidates and at the discretion of the Chief Returning Officer. This information will be uploaded onto the Elections SSMU website and Online Voting System. You may also include 1 picture of yourself to appear on the ballot.

If you would like your pensketch to appear in French, it is your responsibility to have it translated. The deadline is the same for the French version of your pensketch. Elections SSMU highly suggests that you do this, because if you only submit an English pensketch, it will not appear on the ballot when students choose to vote in French.

- **ENGLISH** TEXT MAY NOT EXCEED 150 WORDS IN LENGTH: EXCESS WORDS WILL BE CUT.
- **FRENCH** TEXT MAY NOT EXCEED 175 WORDS IN LENGTH: EXCESS WORDS WILL BE CUT

# Instant Runoff Voting

---

- A method of calculating ranked ballots.
- All first-choice votes shall be counted and allocated to each candidate or Referendum question option.
- If no candidate or Referendum question option receives a majority of the total vote, the candidate or Referendum question option with the fewest votes shall be declared eliminated, and the first choice ballots allocated to that selection shall be redistributed in accordance with the following choice indicated on each voters' ballot.
- This system of eliminating the candidate or Referendum question option with the fewest votes and redistributing ballots according to the next choice of remaining candidates shall continue until one (1) candidate or Referendum question option achieves a Simple Majority
